1. CITIZEN COMMUNICATION

Ryan Sage, member of Roller Girls, spoke on the need for roller rinks in Austin, and requested that the Commission provide funding for a new roller rink in Austin.

Jasyln Dagle, spoke on the need for more space for roller derby in Austin. She spoke on the success of the program and the lack of space in Austin for the increasing number of roller derby participants.

Arturo Rivera, spoke in support of Austin Anarchy, the Austin men's roller derby team, and of the need for a facility for roller derby teams.
