Brent Lloyd went over amendments to the regulations that govern signage, and explained that changes were necessary now, and that further changes could be coming as a part of the CodeNEXT draft code. Any changes now or later to the regulations would be such that content would not be regulated.

Attendees representing the Austin Police Association and sign companies asked that as a part of the changes being made that electronic billboards be permitted. Other attendees supported the draft amendments as they were, and asked that electronic billboards continue to be prohibited in Austin.

A motion was made to recommend the amendment to Planning Commission by Commissioner Seeger, seconded by Commissioner Flores, with additional direction to staff to look at:

- The possibility of keeping UNO sign regulations as they currently are.

Vote: 4-0. (Commissioners Kazi, Denkler, and Greenberg absent).
