- a. Alexandra Bassett with Rude Mechs – Had an open house for their new space at the Austin American Statesmen facility 305 South Congress. They have three available rehearsal spaces available for rent. The 21st season is beginning next week – Crush Austin – making art in each council district.

- a. Austin Veterans Art Festival presented by Glenn Towery of the Veterans Suicide Prevention Channel
Hugh Mayfield and Glenn Towery presenting – Austin Veterans Art Festival – no one is doing a festival of the type that they are proposing. Provide an opportunity for veterans to express how they feel for serving in the military. Created the Veterans Suicide Prevention Chanel, which can be accessed with any device that can access the internet. The idea for the veterans' art festival is new and they are in the early phases of planning. They would like to divide the show over the 6 primary museums in Austin and would like to base each exhibition on a theme. Additionally offer an Art Walk. Ask that galleries to take a reduced commission on the sale of the art work. Have live performances and integrate a book fair. They hope to build it into a national event.
