AN ORDINANCE AMENDING THE FISCAL YEAR 2017-2018 HISTORIC PRESERVATION FUND OPERATING BUDGET (ORDINANCE NO. 20170913-001) TO APPROPRIATE \$5,293,991; AND AMENDING THE FISCAL YEAR 2017-2018 CAPITAL BUDGETS OF CITY DEPARTMENTS INCLUDING THE PARKS AND RECREATION DEPARTMENT, THE AUSTIN TRANSPORTATION DEPARTMENT, AND THE AUSTIN PUBLIC LIBRARY DEPARTMENT (ORDINANCE NO. 20170913-001) TO TRANSFER IN AND APPROPRIATE THESE FUNDS FOR ALLOWABLE HISTORIC RESTORATION PRESERVATION PROJECTS OR ACTIVITIES AS REFLECTED IN THE TEXAS TAX CODE SECTION 351.101(A)(5) WHICH AUTHORIZES HOTEL OCCUPANCY TAX TO BE USED FOR HISTORIC RESTORATION PROJECTS AND ACTIVITIES THAT PROMOTE TOURISM AND THE CONVENTION INDUSTRY AND THAT ARE IN SPECIFIC LOCATIONS IN THE CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** Council amends the Fiscal Year 2017-2018 Historic Preservation Fund Operating Budget (Ordinance No. 20170913-001) to appropriate \$5,293,991 for funding for allowable historic restoration and preservation projects or activities.
- PART 2. Council amends the Fiscal Year 2017-2018 Parks and Recreation Department Capital Budget (Ordinance No. 20170913-001) to transfer in and appropriate \$3,075,000 for funding for allowable historic restoration and preservation projects or activities.
- **PART 3.** Council amends the Fiscal Year 2017-2018 Austin Transportation Department Capital Budget (Ordinance No. 20170913-001) to transfer in and appropriate \$321,700 for funding for allowable historic restoration and preservation projects or activities.
- PART 4. Council amends the Fiscal Year 2017-2018 Austin Public Library Department Capital Budget (Ordinance No. 20170913-001) to transfer in and appropriate \$469,883 for funding for allowable historic restoration and preservation projects or activities.
- **PART 5.** Council amends the Fiscal Year 2017-2018 Economic Development Department Capital Budget (Ordinance No. 20170913-001) to transfer in and appropriate \$500,000 for funding for allowable historic restoration and preservation projects or activities.
