Public notice was given for this solicitation, CLMC694 Concrete and Asphalt Repair North IDIQ, through the City's Vendor Connection web portal. Five bids were received and opened on February 8, 2018. Of the five bids received four were from MBE/WBE certified firms. Smith Contracting Co, Inc. submitted the lowest responsive bid of five bids received:
