Budget

Approve an ordinance amending the Fiscal Year 2017-2018 Historic Preservation Fund Operating Budget (Ordinance No. 20170913-001) to appropriate up to \$5,293,991; and amending the Fiscal Year 2017-2018 Capital Budgets of City Departments including the Parks and Recreation Department, the Austin Transportation Department, and the Austin Public Library Department (Ordinance No. 20170913-001) to transfer in and appropriate these funds for allowable historic restoration and preservation projects or activities as reflected in the Texas Tax Code Section 351.101(a)(5) which authorizes hotel occupancy tax to be used for historic restoration projects and activities that promote tourism and the convention industry and that are in specific locations in the City.

Additional Backup Information:

The Texas Tax Code, Chapter 351.101(a)(5) authorizes hotel occupancy taxes to be used to promote tourism and the convention industry through use of those funds for historic restoration and preservation projects or activities or advertising and conducting solicitations and promotional programs promoting the City to tourists and the convention industry. During adoption of the Fiscal Year 2017-18 budget, the City Manager was directed to bring back to

Council a spending plan for the unallocated funds within the Historic Preservation Fund (HPF) to be used in the manner authorized by this state law. The instructions specified that \$2 million from the HPF was to be used "for allowable operations and maintenance expenditures at City of Austin historic facilities and sites" and that the remaining funding shall be expended "on allowable historic restoration and preservation projects or activities, in accordance with Texas Tax Code Chapter 351.101(a)."On February 26, 2018, Council was provided a memo outlining the spending plan recommended by staff. In summary, 15 projects (shown below), with a total cost of \$5.3 million, have been strategically picked to impact the largest area of the City possible as quickly as possible.
