## **PROPOSAL**

---

Demolish a ca. 1911 house.

## **ARCHITECTURE**

---

One-story, wing-and-gable plan, board-and-batten-sided frame house with a partial-width, shed-roofed independent porch on plain, square wood posts; single 1:1 and 2:2 metal replacement fenestration.

## **RESEARCH**

---

The house appears to have been built around 1911; the first occupants were a widow, Martha A. King, and a carpenter, J. Frank Gipson. They lived here only a year or two until the house was purchased by Henry H. and Nonie Linam, who lived here from around 1913 until Nonie's death in 1961. Henry H. Linam had a number of odd jobs before moving into this house, and was a clerk for Western Union when he and Nonie first lived here. He went on to manage a feed store, then worked for the City Street Department for several years in the late 1910s and 1920s. His sons, Henry L. Linam and Bert B. Linam, established a furniture store in 1927 on E. 6<sup>th</sup> Street in the same location as the former W.J. Shaw Furniture Company (that building is a historic landmark). Henry H. Linam worked as a clerk in his sons' store. He passed away in 1939. After his death, his widow, Nonie Linam, lived in this house until her death in 1961. As an aside, Henry Linam's son, Bert Linam, was the father of world-famous welterweight boxer Bert Linam, who achieved fame in the 1940s and early 1950s.

From the mid-1960s until her death in 1982, the house was owned and occupied by Antonia B. Trevino, a widow. She had no occupation listed in city directories for the time that she lived in this house; the 1940 U.S. Census shows her living on Sabine Street with 4 of her children, all of whom were employed.

## **STAFF COMMENTS**

---

The house was listed as not eligible for individual listing in the East Austin Historic Survey (2016) due to alterations to the doors, windows, and roofing materials, but staff believes that the house retains sufficient integrity to warrant consideration by the Commission.

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a frame wing-and-gable house that has lost some of its integrity of materials in the replacement of the windows, but still retains its basic form and siding materials. The house dates from ca. 1911, making it one of the older houses in the neighborhood, as this section of East Austin was not platted and developed until around 1910. Staff believes that the house could qualify as a historic landmark for its architecture as a good example of turn-of-the-century vernacular residential design for middle-class families in East Austin.
- b. **Historical association.** The house was associated with Henry and Nonie Linam for almost 50 years, but neither appear to have the significance to warrant a designation based upon historical associations. Henry Linam had

several odd jobs before working for the City Street Department, and finally in his sons' furniture store on E. 6<sup>th</sup> Street; these do not appear to qualify for landmark designation under significant historical associations.

- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.




#### **STAFF RECOMMENDATION**

---

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package. The house does not meet the two criteria necessary for individual designation as a historic landmark.

#### **BIOGRAPHICAL NOTES:**

##### **Henry H. and Martha Nonie Linam (ca. 1913 – ca. 1961)**

The 1910 U.S. Census shows Henry and Nonie L. Linam living at 1423 Canterbury Street in Austin. Henry Linam was 40, had been born in Alabama, and was a laborer doing general work. Nonie L. Linam was 35, had been born in Texas, and had no occupation listed. They had 3 children: daughter Eddie M., 15; Henry L., 14; and Bert, 13. The two boys were both messengers for the telegraph office. All the children had been born in Texas.

The 1920 U.S. Census shows Henry H. and Nonie Linam as the owners of this house. Henry H. Linam was 50, had been born in Texas, and was a driver for the City. Nonie Linam was 45, had been born in Texas, and had no occupation listed. They had a son, Bert B., 23, who had been born in Texas and was a driver on a moving truck.

The 1930 U.S. Census shows H.H. and Martha Linam as the owners of this house, which was worth \$1,000. H.H. Linam was 60, had been born in Alabama, and was a helper at a furniture store. Martha Linam was 55, had been born in Texas, and had no occupation listed. They had no children listed with them.

Henry H. Linam died August 18, 1939 and is buried in Elgin, Texas.

# Gun Wounds Are Fatal to Linam

## Burial Scheduled In Young's Prairie

The body of H. H. Linam, 69, who died Friday at noon in Brackenridge hospital of shotgun wounds suffered at his home, 1900 Haskell street, will be taken Saturday at 3:30 p. m. from the Cook Funeral home to Young's Prairie cemetery four miles south of Elgin where funeral services will be held Saturday at 5:30 p. m.

The Rev. Ralph Wolf of Elgin will conduct the services.

Mr. Linam was found Thursday morning at his home critically wounded by a shotgun charge which crushed his left lung, fractured several ribs and lacerated his left arm, investigating officers reported. He had been in ill health for several weeks, the officers said they were told.

Surviving him are his widow, Mrs. Nona Linam of Austin; two sons, Bert and Henry Linam, Jr., both of Austin; and one brother, T. J. Linam of Duncan, Okla.

The 1940 U.S. Census shows Nono Linam as the owner of this house, which was worth \$900. She was a 65-year old widow who had been born in Texas and had no occupation listed.



Martha Nonie Linam died in 1961; her last address was this house. She was born in Elgin, Texas in 1874, and was a widowed housewife. She is buried in Elgin, Texas.

Burial will be in Young Prairie Cemetery near Elgin.

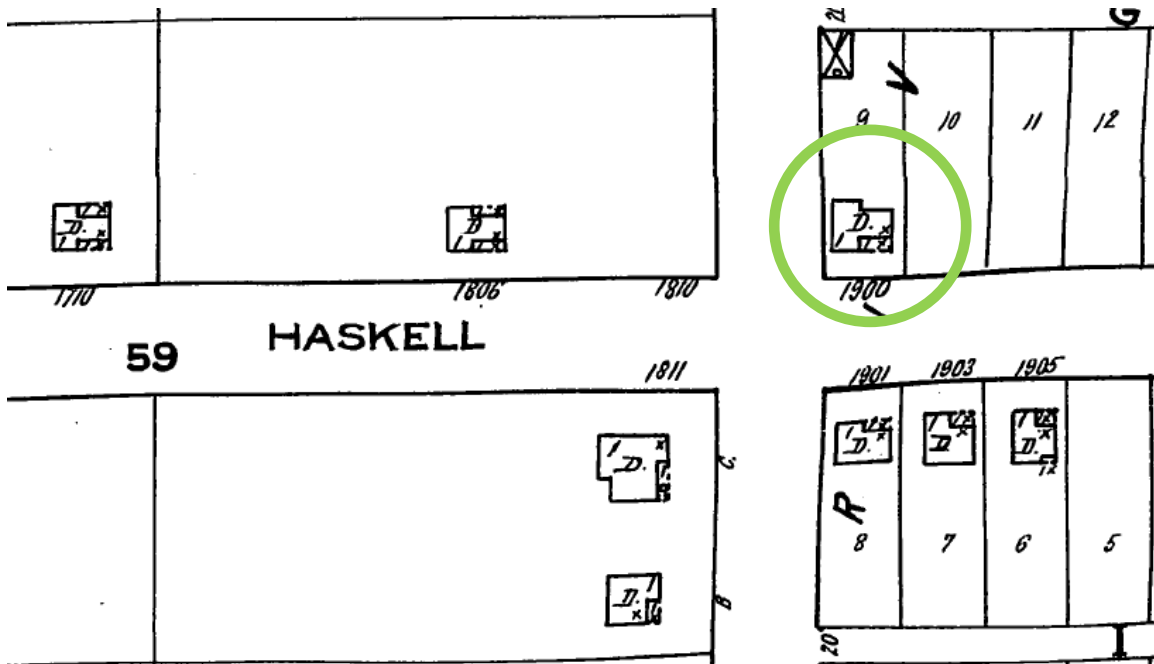

**Antonia B. Trevino (ca. 1965 – ca. 1982)**

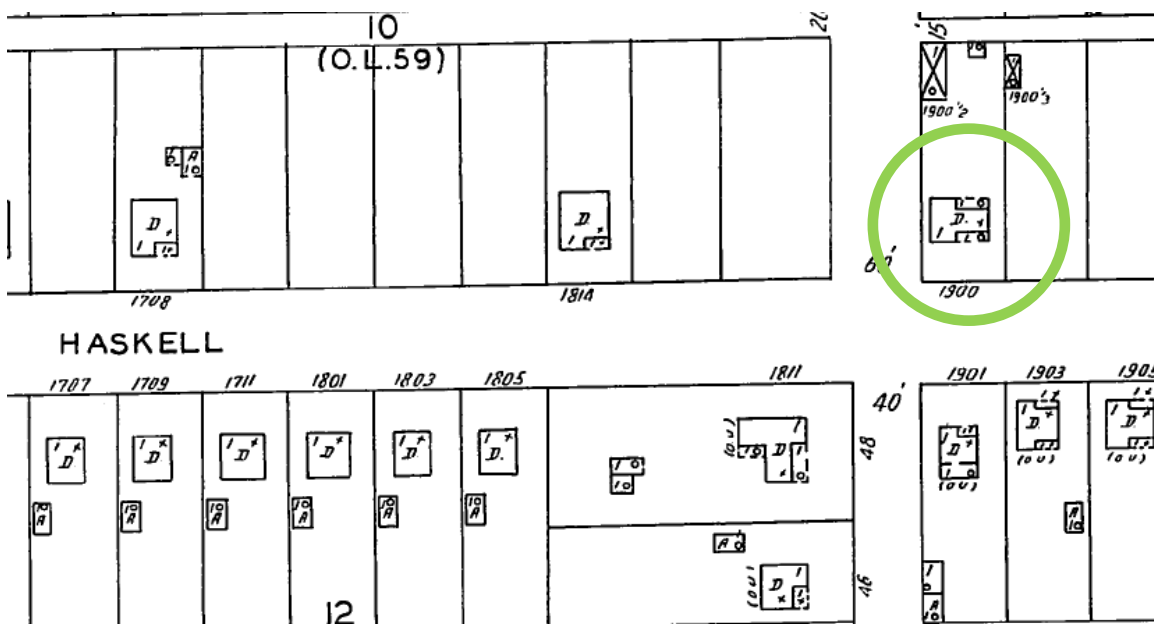

With her lived 4 children: Matthew, 20, a delivery boy for a retail drug store; Frank, 17, a servant in an apartment house; Charlotte, 16, a nursemaid in a private home; and a divorced daughter, Emma Prado, 22, a maid in a doctor's office, and Emma's daughter Beatrice [?], 5. All the family members had been born in Texas.
