**SUBJECT:** Authorize execution of a construction contract with MUNIZ CONCRETE AND CONTRACTING INC., (MBE/MH 93.65 %), Austin, TX, for the construction of the Capital Metropolitan Transportation Authority Group 1 Sidewalk Improvements project in an amount not to exceed \$591,817.79.

As part of an ongoing program to provide A.D.A. compliant sidewalks and curb ramps throughout the City of Austin, new sidewalks will be constructed at seven (7) locations. The new sidewalk construction will be located along South Lamar Boulevard from Brodie Oaks Shopping Center to Barton Skyway (west side), along South Lamar Boulevard from Panther to Barton Skyway (east side), along South Lamar Boulevard from West Mary to Evergreen, along Stassney Lane from South First to IH 35 frontage road, along East Riverside Drive from Burton to Pleasant Valley, along South Lakeshore Drive from East Riverside to Pleasant Valley, and along Montopolis from East Riverside to Highway 71. The contract allows one hundred eighty (180) calendar days for completion of this project.

Bid documents were distributed to ten general contractors. Bids were opened on July 29, 2004. Muniz Concrete and Contracting, Inc. submitted the lowest of 3 bids received:

Muniz Concrete and Contracting, Inc., Austin, TX (MBE/MH)	\$591,817.79
Dayco Construction Company, Austin, TX	\$610,755.17
Smith Contracting Company, Inc., Austin, TX	\$694,098.50

The contractor's choice of work methodology provides for 2 areas of subcontracting opportunities: fuel

68.54% Non M/WBE prime participation; 3.23% MB; 20.4% MH; 1.78% NA; 6.05% WBE; 0% Non M/WBE subcontractor participation.


