ATTACHMENT B

Public Art at Holly Shores Update

The Parks and Recreation Department (PARD) continues to develop the design for the Hike and Bike Trail extension and associated improvements on the 9-acre Holly Power Plant property transferred to PARD by AE. Based on the most recent Holly Shores Phase 1 Improvements update, the construction is on schedule and is still on track to be completed in May 2019. The space will be available for public use at that time. PARD recommends evaluating this new park area for a period of one year after construction completion to understand how the space will function and be used by the public. This evaluation period will allow for further refinement of the RFP and allow for any modifications to the language based on the public use of the space. With the evaluation period in mind, PARD recommends that the earliest date for advertising the Holly Shores Art RFP be in the summer of 2020.
