HISTORIC LANDMARK COMMISSION MAY 21, 2018 DEMOLITION AND RELOCATION PERMITS HDP-2018-0183 1007 W. 22ND STREET

PROPOSAL

Demolish a ca. 1936 duplex.

ARCHITECTURE

Two-story, roughly rectangular-plan, hipped-roof brick-veneered frame duplex; the brick veneer is on the front wall only; recessed principal entry with a gabled pediment; flat-roofed independent porch to the right of the central entry on cast concrete piers with a metal railing above; single and paired 6:6 fenestration.

RESEARCH

The duplex appears to have been built in 1936, and had a series of short-term tenants, mostly associated with the University of Texas. Early tenants included the assistant director of the Texas Old Age Commission and his college-student son, a widow with 3 children attending the University of Texas, and a professor. Herman Henry, and his wife Lottie, who lived here from around 1946 to around1953, was a mail carrier for the Post Office. Mary L. Stone, the chief catalogue librarian for the University of Texas, lived here from around 1950 to around 1980. These were the two (and only) long-term tenants of the duplex. More recent tenants have been UT students.

STAFF COMMENTS

The duplex was not listed in the Comprehensive Cultural Resources Survey (1984).

Staff has evaluated this duplex for designation as a historic landmark and has determined that it does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a brick-veneered frame duplex with Colonial Revival-styled windows and a gable-pedimented entry. While retaining a high degree of integrity, it does not satisfy the criterion for architectural distinction.
- b. **Historical association**. The duplex has had a large number of short-term tenants over the years; the principal long-term tenants were a mail carrier for the Post Office and a librarian at the University of Texas, about whom very little can be discerned.
- c. **Archaeology**. The duplex was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The duplex does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, as the duplex does provide student housing in an older building with character, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. This duplex does not meet the criteria for individual designation as a historic landmark.
