HISTORIC LANDMARK COMMISSION MAY 21, 2018 DEMOLITION AND RELOCATION PERMITS HDP-2016-0698 1408 E. 2ND STREET

PROPOSAL

Demolish a ca. 1897 house.

ARCHITECTURE

One-and-a-half story, rectangular-plan, side-gabled frame house with a full-width inset porch; central, front-gabled dormer containing a pair of 2:2 windows; central entry framed with sidelights and a transom; single 2:2 windows.

RESEARCH

The house appears to have been built around 1897; the first owners and occupants were Gustav Falk and his family, who lived here until the early 1940s. Gus Falk and his wife, Christine, were both born in Sweden, and immigrated to the United States around 1890. Like many in this neighborhood, Gus Falk worked for the Houston and Texas Central Railroad from the 1890s through the 1910s, with an interruption in the mid-1910s for work as an engineer at the Littlefield Building. He then returned to being a car inspector for the railroad in the early 1920s, before starting work for the City Water Department at the city filtration plant, a job he retained for the rest of his working life. He raised his family in this house, including his son, Bibb Falk, a professional baseball player who returned to the University of Texas as the baseball coach for many years. Disch-Falk Field is named for him. In his later years, Gus Falk moved in with his son, Bibb, at a house in Hyde Park, which is a historic landmark.

The house was owned and occupied by a widow, Eula Daily, from the mid-1940s through the mid-1950s. Mrs. Daily was from Williamson County, Texas, and had no occupation listed while she lived in this house.

From the mid-1960s through the early 1990s, the house was owned and occupied by Pete and Frances Rincon. Pedro Rincon, Jr. was born in Texas to Mexican-born parents, who lived in rural Travis County. He was a farm laborer while still living with his parents. Upon his marriage and moving into Austin, Pete Rincon became a cabinet maker and worked in the mill works of Stripling-Blake Lumber Company.

STAFF COMMENTS


The house is not recommended for individual designation nor as contributing to a local or National Register historic district by the East Austin Historic Survey (2016) due to the replacement of doors and exterior siding.

The house was in a serious state of disrepair when this case first came before the Commission in 2016, when staff recommended initiation of a historic zoning case. The house sat vacant for several years at the time of the original hearing in 2016, and the thenowner attempted to sell the property rather than attempt to rehabilitate and preserve the house. Since 2016, the house has fallen into further decline, and has suffered major deterioration from the collapse of a section of the roof. The current owner purchased the property with the intention of restoring the house, but has since determined that it is not financially feasible to do so given the level of deterioration. The current owner (who purchased the property this past winter) met with the Certificate of Appropriateness Review Committee in May, 2018 and presented evidence in support of an application for

demolition of the structure. The Certificate of Appropriateness Review Committee members agreed that the house is beyond repair and that the current owner exercised due diligence in considering preservation and restoration of this house, and that a recommendation to approve a demolition permit was an unfortunate but necessary action at this time.

STAFF RECOMMENDATION

Staff must reluctantly agree with the members of the Certificate of Appropriateness Review Committee to release the demolition permit, but recommends the completion of a City of Austin Documentation Package to the greatest extent possible after the boards have been removed from the windows and doors, as well as the salvage of any usable materials from the inside and exterior of the house. There are still many fine examples of vernacular Victorian woodwork on the house, and the configuration of the windows and doors should be salvaged if possible for re-use on this or another site.

Gus and Christine Falk (ca. 1897 – ca. 1942)

The 1900 U.S. Census shows Gustav and Christina Falk at this address. Gustave Falk was 31, had been born in Sweden, and was a boiler washer for the railroad. Christina Falk was 35, had been born in Sweden. They had 4 children: Elsie, 7; Nellie, 6; Gustave O, 4; and August, 1. All of the children had been born in Texas.

The 1910 U.S. Census shows Gustav and Christine Falk at this address. Gustav Falk was 42, had been born in Sweden, and was a car inspector for the railroad. Christine Falk was 45, had been born in Sweden, and had no occupation listed. They had 6 children: Elsie, 18, a type writer for the city; Nellie, 16; Arthur, 14; August, 11; Carl, 8; and Chester, 5. All of the children had been born in Texas.

The 1920 U.S. Census shows Gustav and Christina Falk as the owners of this house. Gustav Falk was 50, had been born in Sweden, and was a car inspector for the railroad. Christina Falk was 55, had been born in Sweden, and had no occupation listed. They had 5 children: Elsie, 27, a stenographer for a music store; Arthur, 23, a book-keeper in a flour mill; August, 21; Carl, 17; and Chester, 14. All of the children had been born in Texas.

The 1930 U.S. Census shows Gus H. and Christine Falk as the owners of this house, which was worth \$5,000. Gus H. Falk was 60, had been born in Sweden, and was an operator at the City Filtration Plant. He had become a naturalized citizen in 1888. Christine Falk was 65, had been born in Sweden, and had no occupation listed. She had become a naturalized citizen in 1890. They had 2 of their children living with them: Bibb A., 31, who had been born in Texas, and was a professional baseball player; and Chester, 24, who had been born in Texas, and was a professional baseball player.

The 1940 U.S. Census shows G.H. and Christine Falk as the owner of this house, which was worth \$3,500. G.H. Falk was 71, had been born in Sweden, and was an operator at the City Filtration Plant. Christine Falk was 74, had been born in Sweden, and had no occupation listed. With them lived their son, Bibb, 41, who had been born in Texas, and was a professional baseball player.

Her 1952 death certificate shows that Christine Falk was born in 1864 in Sweden and was living at 4213 Avenue D at the time of her death. She was a housewife.

According to his 1963 death certificate, Gustaf Harald Falk was born in Wadstena, Sweden in 1869, and was living at 4213 Avenue D at tht time of his death. He was a widowed retired city employee.

Her 1980 death certificate shows that Elsie Maria Falk, the oldest daughter of Gus and Christine Falk, was born in 1892 in Texas, and was living at 4213 Avenue D at the time of her death. She was never married, and worked as a secretary for an insurance agency.

They had 5 children: Nelson, 15 (who was Eula's son from a prior marriage); Jeannie Sue, 13; L.C., 11; Cyril H., 9; and Morris L., 6. All of the children had been born in Texas. The family had lived in rural Williamson County in 1935.

The 1930 U.S. Census shows Landon C. and Eula Daily living in a house they owned in Precinct 8 of Williamson County, Texas. Landon C. Daily was 23, had been born in Texas, and was a labeler in a broom factory. Eula O. Daily was 36, had been born in Texas, and had no occupation listed. They had 2 children: Geneva S., 2; and Landon C., Jr.,1. In addition, two of Eula's children from her prior marriage lived with them: Maxine F. Ponder, 9; and Nelson E. Ponder, 5. All of the children had been born in Texas.

The 1910 U.S. Census shows Eula as the 16-year old daughter of John and Johnnie Putnam, who lived on the Lower Georgetown Road in Travis County. Eula was the oldest of the couple's 5 daughters listed. Her father, John Putnam, was a 39-yaer old Mississippi-born farmer. Her mother, Johnnie Putnam, was 44, had been born in Mississippi, and had no occupation listed. All of the girls were listed as farm laborers on the home farm. The 1900 U.S. Census shows the Putnams living in Justice Precinct 8 of Williamson County, Texas on a rented farm. John Putnam was a farmer.

Her 1977 death certificate shows that Eula Olive Daily was living at 5114 Martin Avenue at the time of her death. She was born in 1893 in Hutto, Texas, and was a homemaker. She was a widow.

Apparently, Landon and Eula Daily divorced – he died in Round Rock, Texas in 1986.
