Authorize award and execution of a construction contract with Mastec North America, Inc., for Fiscal Year 2018 Traffic Signal Maintenance - Indefinite Delivery/Indefinite Quantity contract in the amount of \$998,685.00 for an initial 1-year term, with four 1-year extension options of \$800,000 each, for a total contract amount not to exceed \$4,198,685. [Note: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 4.73% MBE and 1.09% WBE participation.]

Additional Backup Information:

As the City of Austin grows, so does the need to install, modify and repair existing traffic control devices to manage traffic and improve safety. This contract with Mastec North America, Inc. will allow the City of Austin to repair, modify and install various traffic control devices on Austin's roadways such as traffic signal poles and foundations and vehicular detection devices. This Indefinite Delivery/Indefinite Quantity contract will be used to support the Austin Transportation Department.

Indefinite Delivery/Indefinite Quantity contracts provide for an indefinite quantity of services for a fixed time, usually an initial term with extension options. They are commonly used when precise quantities of supplies or services, above a specified minimum, cannot be determined. Indefinite Delivery/Indefinite Quantity contracts help streamline the contract process and service delivery and allow the City the flexibility to add work as needs arise or change. As each project is defined, a specific work assignment will be given to the contractor who will complete the scope of work for the unit prices included in the contract. Work deadlines will be established for each work assignment.

The base bid was used to identify and determine the lowest responsive bidder and to determine contract unit prices for each bid item and the lowest bidder.

This request allows for the award and execution of a construction contract with Mastec North America, Inc. for an estimated period of 1 year with four 1-year extensions. However if funds for the initial term are expended staff may accelerate the extension options, but in no event will exceed the total contract amount. The extension options are subject to the agreement of both parties.

A delay in awarding this contract could negatively affect the City's ability to repair and maintain traffic signals throughout the City of Austin.

This project is located city-wide.
