**Additional Backup Information:**

City Code Chapter 13-2 governs the oversight and regulation of ground transportation passenger services, including those by charter bus, charter van, limousine, pedicab, electric low speed vehicle, horse drawn carriage, and taxicab.

The Austin Transportation Department (ATD) requests Council approve the proposed ordinance to amend certain sections of City Code Chapter 13-2 pertaining to the City’s taxicab regulations. These amendments are intended to modernize the current Austin taxicab model and to allow companies to operate on a level playing field with other ground transportation passenger services not regulated by the City of Austin, such as Transportation Network Companies (TNCs).

The proposed ordinance will allow taxicab companies to operate more competitively by allowing for flexible fares and flat rates, flexible taxicab fleet numbers, virtual meters, the removal of third-party inspection requirements, and certain cost-prohibitive trade dress requirements, while enhancing incentives for electric and ADA compliant taxicab vehicles. ATD led extensive stakeholder outreach related to the regulatory reform and broad consensus was reached.

This recommendation for Council action is part of an effort to modernize/reform much of City Code 13-2 related to ground transportation services. The Austin City Council previously approved Ordinance No. 20171214-095, reforming regulations applicable to limousine and charter passenger services.
