

URBAN RENEWAL BOARD DRAFT MINUTES

REGULAR MEETING February 26, 2018

The Urban Renewal Board convened in a regular meeting on Monday, December February 26, 2018, at the Street-Jones Building, 1000 East 11th Street, Room 400A, Austin TX.
