ORDINANCE NO.

AN ORDINANCE SETTING THE CALENDAR YEAR 2019 RATE OF ASSESSMENT FOR THE AUSTIN DOWNTOWN PUBLIC IMPROVEMENT DISTRICT WITHIN THE CITY OF AUSTIN AND APPROVING A PROPOSED CALENDAR YEAR 2019 ASSESSMENT ROLL FOR THE DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council finds that:

- (A) Chapter 372 of the Texas Local Government Code authorizes the creation of the Austin Downtown Public Improvement District (District).
- (B) On October 11, 2012, the City Council passed a resolution, which approved the reauthorization of the District in accordance with its findings.
- (C) The Council finds that the proposed assessment roll attached as Exhibit A, and incorporated in this ordinance, is necessary to fund improvements and services provided through the District.
- **PART 2.** The Austin Downtown Public Improvement District assessment rate for calendar year 2019 is set at ten cents per \$100.00 of property value. Property value is determined by the Travis Central Appraisal District appraisal, subject to an amendment to an assessment made by Council after a hearing.
- **PART 3.** The Council directs that the proposed assessment roll attached as Exhibit A be filed with the City Clerk. The following property shall be excluded from the roll and exempted from payment of the assessment:
 - (A) City property used for a public purpose;
 - (B) Property owned by the County, or a political subdivision of the State of Texas and used for a public purpose;
 - (C) Property exempt from taxation under Section 11.20 (*Religious Organizations*) of the Texas Tax Code;
 - (D) Property used exclusively for school purposes, as identified by the Travis Central Appraisal District records;
 - (E) Property owned by an association engaged in promoting the religious, educational, or physical development of boys, girls, young men, or young women operating under a state or national organization and used exclusively

46 47 48	PART 4. Property designated by the City as "H" Historic is assessed on the basis of the value prescribed in Section 11-1-22 of the City Code (<i>Determination of Exemption Amount</i>).			
49 50	PART 5. The City Council approves the attached Exhibit A as the proposed calendar year 2019 assessment roll for the District.
