Recommendation

The Ethics Review recommends the Austin City Council consider its recommendations in the attached report related to the Charter Review Commission's recommendations.

Description of Recommendation to Council

The Commission amended and adopted the attached report of its working group, to communicate the following concerns to Council in regard to the recommendations of the Charter Review Commission related to an independent ethics review commission (IERC) and the "Democracy Dollars" program:

- 1. Selection and qualification of members to the proposed IERC:
 - (a) The City Auditor's Office should not be involved in the selection process of members to the proposed independent ethics review commission (IERC).
 - (b) The proposed qualifications for IERC members should be loosened as the qualifications would result in a limited number of citizens who would be eligible to serve on the IERC.
- 2. The term of office of members to the proposed IERC: The five-year term length is too long, especially in light of the requirement that former members refrain from almost any political activity during their term and for two years after their term.
- 3. The cost of the proposed IERC and the "Democracy Dollars" program: The costs of the proposed IERC and the "Democracy Dollars" program and the source of the funds to satisfy these costs have not been adequately studied or substantiated.

REPORT FROM ETHICS REVIEW COMMISSION WORKING GROUP'S REVIEW OF 2018 CHARTER REVIEW COMMISSION'S REPORT TO CITY COUNCIL DATED MAY 7, 2018

I. Introduction

The Austin 2018 Charter Review Commission submitted its final report (the "Report") to the Austin City Council on May 7, 2018. Contained in the Report are two items that would directly impact the operations of the Austin Ethics Review Commission (the "ERC"), including eliminating the ERC and replacing it with an Independent Ethics Review Commission (the "proposed IERC").

At its May 9, 2018 meeting, the ERC created a working group (the "Working Group") to review the Report and to present its finding to the ERC. The Working Group consists of the following ERC commissioners: Thompson, Danburg, Soberon, and McCormick. On May 18, 2018, the Working Group met with all members present to discuss the Report. This report contains the Working Group's comments and concerns regarding the Report.

II. Items Not Addressed

The Working group took no position regarding the IERC or the "Democracy Dollars" Program broadly. Rather, the Working Group worked to develop consensus on the particular items addressed below based on the ERC's experience and expertise.

III. Items of Concern and Conclusions

The Working Group discussed the following areas of concern regarding the Report:

- 1) The selection and qualification of members to the proposed IERC.
 - The Working Group discussed the selection of members to the proposed IERC. In particular, the Working Group discussed the apparent conflict of interest that would arise if the City Auditor's Office is involved in the selection process while at the same time serving as what amounts to the prosecutor in cases involving alleged violations of the City's ethics rules, which would be decided by the proposed IERC. The Working Group discussed the fact that this potential conflict seems even more glaring in light of comments from the City Auditor's Office regarding recent decisions by the ERC.
 - The Working Group concluded that the City Auditor's Office should not be involved in the selection process of members to the proposed IERC.

- The Working Group discussed the qualifications for proposed IERC members. In particular, the Working Group discussed the limited number of citizens who would be eligible to serve on the proposed IERC under the proposed qualifications requirements.
 - The Working Group concluded that the limitations regarding who may qualify for membership to the proposed IERC should be loosened.
- 2) The term of office of members to the proposed IERC.
 - The Working Group discussed the five year term length of members to the proposed IERC.
 - The Working Group concluded that the five year term length is too long, especially in light of the requirement the former members refrain from almost any political activity during their term and for two years after their term.
- 3) The cost of the proposed IERC and the "Democracy Dollars" Program.
 - The Working Group discussed costs of the proposed IERC and the proposed "Democracy Dollars" program, both of which would impose substantial additional costs to the City, including the cost of the proposed vouchers and the proposed addition of an Executive Director and additional staff to aid the proposed IERC.
 - The Working Group concluded that the costs of the proposed IERC and the Democracy Dollars program and the source of the funds to satisfy these costs have not been adequately studied or substantiated.

IV. Conclusion

The Working Group had other concerns with the Report, but the ones listed above constitute the specific concerns for which there was broad consensus in the Working Group. The Working Group will propose that the ERC adopt a resolution addressing these concerns at the next regularly scheduled ERC meeting on June 13.
