HISTORIC LANDMARK COMMISSION JUNE 25, 2018 DEMOLITION AND RELOCATION PERMITS HDP-2018-0282 2502 INWOOD PLACE

PROPOSAL

Demolish a ca. 1949 house.

ARCHITECTURE

One-story, rectangular-plan, flat-roofed frame house stone wainscot and accent walls, and reflects the transition from International style to a mid-century Modern design aesthetic; metal-framed multi-lite casement windows.

RESEARCH

The house was built in 1949 by Kenneth Fink, an engineer at an air-conditioning contractor. He and his wife Barbara lived here until around 1953. Glen Ramsey, a psychologist, is listed as the owner of the house in the mid-1950s; the house was then owned and occupied by a civil engineer, Holton F. Cook, and his wife, Catherine, until themed-1960s. The house was then briefly a rental property, then purchased by Paul E. Russell and his wife Cosette, who lived here until very recently. Paul Russell taught engineering courses at the University of Texas, and then worked as a computer programmer for various state agencies. After his retirement in 1999, he went back to teaching at Austin Community College.

STAFF COMMENTS


The house is not listed in any City survey to date.


Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. Architecture. The house is a good example of a transitional house reflecting both International style and mid-century Modern design, with a long, low profile, large areas of window glass, and the use of native materials, especially the stone accent walls and wainscot on the house. However, this style and configuration is relatively common in Austin, and this house does not exhibit any distinctive architectural features that sets it apart from other houses of similar style and vintage.
- b. **Historical association**. The house was the home of an air conditioning engineer for a few years after it was built, then of an engineering professor at the University of Texas who later worked as a computer programmer for state agencies. There do not appear to be significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

Paul Eugene Russell Paul Eugene Russell passed away peacefully at home on December 29, 2011. He was born and raised in Orange, CA. Growing up in southern California, he enjoyed surfing, beach volleyball and sailing. He graduated from Stanford University with a Ph.D. in aerospace engineering. In the 1970s, Paul passed the examinations required to become a member of Mensa. He also was a member of Sigma Xi for many years. His love of learning was fueled by a voracious appetite for reading on a myriad of topics. He expressed his love for art through life drawing. His most noted influences included Picasso, Matisse and Henry Moore. For more than 30 years, Paul attended Saturday morning drawing sessions at Elizabet Ney Art Museum and later at Hancock Recreation Center. He formed strong friendships with his fellow artists and leaves behind numerous charcoal and ink drawings that will be cherished for years to come. In 1961, he married Cosette Sargeant and they moved to Clear Lake City, TX, where he performed contract work for NASA. Soon after, the hills of central Texas called him to Austin. Upon viewing the skyline, Cosette exclaimed that this was home. In 1967, Paul began his second career teaching engineering courses at the University of Texas at Austin where he received recognition for outstanding academic advising. He eventually transitioned to work for a number of state agencies as a computer programmer. These included the Texas Air Control Board, Texas Employment Commission, and State Comptroller's Office. Simultaneously, he continued to hone his craft as a teacher while working as an adjunct professor in the IT Department at Austin Community College. While at ACC, he was called upon to participate in several grant funded National Science coseFoundation studies. After retiring from the state in 1999, he became a full-time associate professor. He regularly received recognition as a distinguished faculty member while working at the Rio Grande, Riverside and Northridge campuses. In May 2011, Paul retired. His volunteer work included founding and organizing the Olympic Way League summer swimming program in the 1970s at Westenfield Pool where all three of his children flourished and competed. Later, he was involved with the parent's association for Austin Aquatic Club and Longhorn Aquatics. Despite his many responsibilities, he always found time to pursue other interests including handball, karate, cycling, swimming, tai chi and qi gong. Many of his vacations were spent on Maui and Kauai. Brenneke's Beach was his favorite for body surfing. He would surf throughout the day and enjoy numerous sunsets with Cosette. Paul always had something nice to say about everyone he met and set a wonderful example for his children on how to view life and handle its challenges. He loved his family and will be dearly missed by those who knew him. His greatest gifts were modesty and selfless devotion to his family, students and co-workers. He is survived by Cosette, his wife of 50 years; brother Roger Russell of Orange, CA; daughter Laurie Painter and husband Theo Painter, III of Austin; daughter Aysha White and husband James White of Austin; son Bennett Grey of San Antonio; and grandchildren Katharine Painter, Theo Painter, Marissa Abrego, Tommy White, and Chloe White.
