## HISTORIC LANDMARK COMMISSION JULY 23, 2018 DEMOLITION AND RELOCATION PERMITS HDP-2018-0334 1410 GARDEN STREET

#### **PROPOSAL**

Demolish a ca. 1925 house.

#### ARCHITECTURE

One-story, rectangular-plan, clipped side-gabled frame bungalow with a partial-width, front-gabled independent porch on stone piers and battered wood posts; single, paired, and triple 1:1 fenestration with decorative Craftsman-style screens.

#### RESEARCH

This house appears to date from around 1925, or could be a major bungalow-style remodeling of an earlier house, but if we take the current appearance as a guide to the history of the property, it begins with the family of Earnest and Lena Mangelsdorf, who lived in the earlier house on this site and appear to have built or remodeled this one around 1925. The Mangelsdorf family moved onto this property around 1911, and into a house that had been built around 1905, clearly not this house, although the first Sanborn map to show this area was that of 1935, which does not assist in our evaluation. Earnest Mangelsdorf was a native of Germany, and worked as a miller for Jacob Stern's Capital City Corn and Grist Mill on E. 6th Street. After his death in 1936, his widow Lena continued to live in this house until her death in 1948. They had 3 children: the oldest son Charles, was a printer for the newspaper, and there were two spinster daughters: Hedwig ("Hettie"), a nurse; and Mary, a stenographer for an insurance and real estate brokerage. The sisters lived in this house until around 1950.

Carlos and Julia Rodriquez purchased the house around 1950, and lived here at least through the 1990s. Carlos Rodriquez was a ditch digger and a pipe layer for Joe Bland Construction, a utility contractor.

#### STAFF COMMENTS

The house is recommended as contributing to the potential South East Austin historic district in the East Austin Historic Resources Survey (2016), but staff believes it would also be contributing to a smaller historic district along Garden Street.





Staff has evaluated this house for designation as a historic landmark and has determined that the house may meet the criteria for landmark designation as set forth in City Code:

- a. Architecture. The house is an excellent example of a mid-1920s bungalow with clipped side gables, a hallmark of the mid-1920s phase of bungalow design in Texas; it is remarkably intact and possesses architectural distinction for its representation of bungalow style.
- b. **Historical association**. The house was owned and occupied by members of the Mangelsdorf family from at least 1925 until around 1950. While members of this family may not stand out individually as historically significant, the house represents a solidly middle-class housing type, reflecting the family who built and lived here. Earnest Mangelsdorf was a German immigrant who worked his entire life in Austin as a miller in a grist mill.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

#### STAFF RECOMMENDATION

Postpone to August 27, 2018 to fully evaluate alternatives to demolition of this house, which is definitely contributing to a potential historic district in the neighborhood, and could also be considered individually as a historic landmark. If the Commission votes to release the permit instead, then staff encourages rehabilitation and adaptive re-use, then relocation over demolition, and completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

Ernest and Lena Mangelsdorf (ca. 1911 – ca. 1948)

**Mary Mangelsdorf (ca. 1911 – ca. 1950)** 

The 1910 U.S. Census shows Ernest and Lena Mangelsdorf at 1402 Willow Street. Ernest Mangelsdorf was 45, had been born in Germany, and was a miller in a grist mill. Lena Mangeldorf was 40, had been born in Texas to German-born parents, and had no occupation listed. They had 3 children: Charles, 15; Hedwig, 12; and Mary, 8. All three children had been born in Texas.

Earnest and Lena Mangelsdorf appear in the 1920 U.S. Census as the owners of the house with this address. Earnest Mangelsdorf was 55, and was a miller in a grain business. Earnest Mangelsdorf immigrated to the United States from Germany in 1881; he became a naturalized citizen in 1900. Lena Mangelsdorf was 50, had been born in Texas, and had no occupation listed. Their two daughters lived with them: Hettie, 22, an operator for the telephone company; and Mary, 15, who had no occupation listed. Both girls had been born in Texas..

The 1930 U.S. Census shows Ernest A. and Lena Mangelsdorf as the owners of this house, which was worth \$2,000. Ernest A. Mangelsdorf was 65, had been born in Germany, and was a miller in a grain store. Lena Mangelsdorf was 60, had been born in Texas to German-born parents, and had no occupation listed. They had two daughters listed with them: Hedwig, 32, a nurse in a hospital; and Mary, 28, a stenographer in a private office. Both women had been born in Texas.

Lena Mangelsdorf appears as a 71-year old widow in the 1940 U.S. Census. She was the owner of this house, which was worth \$3,500. She was born in Texas and had no occupation shown. With her lived her daughters: Hettie, 42, a private nurse; and Mary, 38, a stenographer for the Robbins Company. Both women had been born in Texas.



Corporal Charles H. Mangelsdorf of Austin, Rnown well in concellon with his trade of printer, who is a volunteer soldier in the United States expeditionary forces in France, has written to his parents in Austin, Mr. and Mrs. Farnest Mangelsdorf, 1410 Garden Street, that he lost his right foot by amputation after receiving a shrapnet wound while in action during the first week of October last. Following is the letter the parents received last Wednesday:

#### Wrote Lying on His Back.

October, 13, 1918,

Dearest Mother and Father o' Mine:
Somewhere in France is a foot that belongs to me. During battle a week ago I was shot in the foot with shrapnel, necessitating the amputation at the right ankle. The doctors say I am getting along fine and will be in the next convoy back to the States—where I get a cork foot.

Pretty hard to write while lying on

my back.
Tell Ed "hello."
Love to all.

#### The Corporal's Army Record.

Corporal Mangelsdorf is 24 years old. He was serving his apprenticeship in the office of the Steck Printing Company when he enlisted. He began his apprenticeship in the composing room of The Statesman.

He entered the army when trouble was first threatened with Mexico and saw eleven months of duty on the border before being sent to France with Company F. Second Texas Infantry. He was in charge of the officers' mess while stationed at Camp Bowie and made many warm friendships at that time.
