Public notice was given for this solicitation, CLMC712 Hornsby Bend Biosolids Mgt. Plant Thickener Complex Rehab, through the City's Vendor Connection web portal. Two bids were received and opened on June 7, 2018. Of the two bids received none of the firms submitting were certified MBE/WBE. Matous Construction, Ltd., submitted the lowest responsive bid of two bids received including three allowances totaling \$75,000:
