# AUSTIN CITY COUNCIL MINUTES

# WORK SESSION MEETING TUESDAY, JUNE 12, 2018

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, June 12, 2018, City Hall at 301 W. Second Street, Austin, Texas.

#### Mayor Adler called the Council Meeting to order at 9:12 a.m.

D.2. Discussion and possible action regarding a comprehensive revision to the Land Development Code, commonly referred to as 'CodeNEXT,' relating to the regulation of land use and development in the City of Austin and its extraterritorial jurisdiction, together with related actions and City Code amendments. (No public comment will be taken).

Presentation was made by Lauren Avioli, Planner, Neighborhood Housing and Development Department.

**<u>I.A.1</u>**: What is our income-restricted housing goal? What capacity is needed to reach that goal? How often should we evaluate and re-calibrate the program to ensure we meet that goal?

Direction was given to staff to:

- Provide links to the online maps and table that show the properties that have subsidized units funded or created through incentive programs such as the density bonus program.
- Any analysis from the UT Gentrification Study, the Anti-Displacement Task Force or others that would identify how many renters were dismissed from their complexes due to demolitions versus just market rate increases and rent due to housing supply.
- Provide the map in draft 3 that provides the analysis with regard to the density bonus program that shows where it is believed the 6600 capacity will be achieved.
- Provide maps of the sub-areas (rental map and ownership map) and the link to the proposed general administrative procedures for affordable housing and downtown density bonus program.

**<u>II.A.1</u>**: What should be our overall housing capacity goal to meet the goals in Imagine Austin and the Strategic Housing Blueprint?

Council agreed by consensus on support for the following statement "One of the goals of CodeNEXT should be to allow an overall housing capacity that lets us reach the Strategic Housing Blueprint and Imagine Austin goal of 135,000 housing units being built in the city in the next 10 years to address our housing needs." Council agreed by consensus on support for the following statement "Our housing goals should be achieved equitably throughout the city." **<u>I.A.1</u>**: How often should we evaluate and recalibrate the program to ensure we need that goal?

Council agreed by consensus on support for the following statement "The fee in lieu where allowed has to be calibrated at least equal to the costs of the unit on-site (includes all costs)." Council Member Houston (5), Council Member Casar (4), Council Member Kitchen (5), Council Member Renteria (5), Council Member Flannigan (4), Mayor Adler (5), Mayor Pro Tem Tovo (5), Council Member Alter (5), Council Member Garza (4). Council Member Pool was off the dais. Council Member Troxclair was absent.

Council did not agreed by consensus for support for the following statement "Council should approve all fee in lieu of requests for residential projects including exceptions to on-site units such as donation of land. Council Member Houston (4), Council Member Kitchen (2), Council Member Renteria (5), Council Member Flannigan (1), Mayor Adler (2), Mayor Pro Tem Tovo (5), Council Member Alter (5), Council Member Pool (5), Council Member Garza (3). Council Member Casar was off the dais. Council Member Troxclair was absent.

**Direction was given to staff to:** 

- Provide links and copies of the maps that show where the zones are that have density bonuses in them and the maps that apply the set-aside percentage to the specific geographies.
- Circumstances when a request would go to Planning Commission vs. Council using the process for variances as a model. Criteria that would guide when a fee in lieu of would be appropriate.

Direction was given to staff to include in the proposal significantly higher green building ratings; living wage and prevailing wage should be part of any jobs on site and in terms of the construction; to see significant public use of the site; and to conduct a check to ensure that the proposal meets the community values.
