

### M/WBE Summary

Project specific subgoals stated in the request for qualifications were 0.99% African American; 2.98% Hispanic; 2.24% Native/Asian; 2.20% WBE. The Contractor submitted a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Public notice was given for request for qualifications for CLMA026 Downtown Chiller Capacity Addition, through the City's Vendor Connection web portal. Five firms submitted proposals which were received on March 1, 2018. Of the five proposals received, one proposal was from a MBE/WBE certified firm. Of the five firms evaluated, Spawglass Contractors, Inc. was determined to be the best value:
