



## **HUMAN RIGHTS COMMISSION MINUTES**

**REGULAR MEETING  
MONDAY, April 23, 2018**

The Human Rights Commission convened in a regular meeting on Monday, April 23, 2018 at 301 West Second Street in Austin, Texas.

Chair Sareta Davis called the Board Meeting to order at 5:32 p.m.

Board Members in Attendance: Chair Davis, Vice Chair Caballero, Commissioner Brown, Commissioner Casas, Commissioner McMahon, Commissioner Miguez, Commissioner Normand, and Commissioner Yang.

Staff in Attendance: Rosary Arellano, Administrative Senior, Equal Employment/Fair Housing Office (EE/FHO), Human Resources Department (HRD); and Jonathan Babiak, Business Process Consultant, EE/FHO, HRD

### **1. CITIZEN COMMUNICATION: GENERAL**

Matthew Ramirez, Planner, City of Austin Neighborhood Housing and Community Development Department, addressed the Commission to encourage everyone to participate in the Fair Housing Survey.

### **2. NEW BUSINESS**

- a. Discussion and possible action to have Commissioners establish goals and objectives for 2018-19, including plans and strategies for meeting those objectives: Introductions and Process Review; Overview of Commission Purpose and Charge; and Work Plan/Major Goals. (Davis/Caballero)

Kyle Boisjoli, Performance Consultant, City of Austin Human Resources Department, Organization Development Division, facilitated the Commission to develop the following proposed Commission goals and objectives for 2018-19:

- i. Affordable Housing & Gentrification
- ii. Engagement: Process, Partnerships, and Community
- iii. Addressing Disparate Impacts
- iv. Institutional Racism, Gender Equity, and LGBTQ+ Inclusion & Discrimination
- v. Immigrant Rights
- vi. Police Accountability

The proposed goals and objectives were approved on a vote of 8-0: Chair Davis motion, Commissioner Brown second. Voting in favor were Chair Davis, Vice Chair Caballero, Commissioner Brown, Commissioner Casas, Commissioner McMahon, Commissioner Miguez, Commissioner Normand, and Commissioner Yang. Commissioner Avashia and Commissioner Royall were absent.

- b. Discussion and possible action regarding community policing needs and best practices for developing an evidence-based staffing plan for the Austin Police Department to

improve effectiveness, transparency, and efficiency, including tools to assess effectiveness of any adopted accountability strategy in response to City Council Resolution No. 20180322-047 dated March 22, 2018. (Davis/Caballero)
