

THE LIBRARY COMMISSION MINUTES

REGULAR MEETING 23 July, 2018

The Library Commission convened in a Regular Meeting on Monday, July 23, 2018 at the North Village Branch Library, 2505 Steck Ave., in Austin, Texas.

Chair Chad Williams called the Board Meeting to order at 6:00 p.m.

2. Approval of Minutes from June 25, 2018 Regular Meeting:
