CALL TO ORDER

Chair Acuna called the Commission Meeting to order at 6:05 pm.

1. CITIZEN COMMUNICATION: GENERAL

2. NEW BUSINESS

2a. Alkyd/Oil Paint Contract

Commissioner Howry asks how current paint is being recycled, Mr. McHale, ARR, informs Commissioner Howry that the new contract will allow paint to be collected and recycled.

A motion to decline the solicitation due to lack of competition was made by Commissioner Howry. The motion dies due to a lack of second.

Chair Acuna asks for clarification if there was another bidder. Dawn Whipple, ARR, confirms there were two bidders.

Motion made by Commissioner Gattuso to approve. Seconded by Commissioner Masino. Vote 5-1; nay vote was made by Commissioner Howry. Item does not pass.

2b. ZWAC/Parks and Recreation Board Joint Task Force

A motion to appoint Commissioners Masino and White – and Chair Acuna as back-up – was made by Commissioner Gattuso. The motion was seconded by Commissioner Rojo. Vote: 6-0, unanimous.

A motion was made by Commissioner White to appoint Andrew Dobbs and John Rooney as two of the three non-ZWAC stakeholder to the task force. Motion was seconded by Commissioner Gattuso. Vote was 6-0, unanimous.

A motion was made by Commissioner Masino to pre-approve any member PARD decides to add to the task force. Commissioner Gattuso seconds the motion. Vote was 6-0, unanimous.

ADJOURNMENT A motion to adjourn the meeting was made by Chair Acuna, seconded by Commissioner White on a unanimous decision. The meeting was adjourned by Chair Acuna at 6:20 pm to no objection (Unanimous).
