

NOTES:

- 1. A STRAIGHT EDGE OR OTHER TYPE OF THIN BLADED DEVICE SHALL BE USED TO DISPLACE THE AGGREGATE IN THE FRESHLY PLACED CONCRETE. THE AGGREGATE CAN BE DISPLACED BY USING A BACK AND FORTH MOTION APPROXIMATELY 2-INCHES DEEP.
- 2. THE ZIP STRIP (OR APPROVED EQUIVALENT) SHALL BE INSERTED INTO THE CONCRETE WHEN THE CONCRETE IS STILL WET.
- 3. THE TOP PORTION OF THE ZIP STRIP SHALL BE REMOVED LEAVING THE VERTICAL PORTION IN THE CONCRETE, PRIOR TO THE BROOM FINISH (SEE DETAIL "A" ON THIS SHEET).
- 4. THE NEW JOINT FORMED SHALL BE BROOM FINISHED OVER THE TOP OF THE JOINT.
- 5. THE CONTRACTION JOINT PATTERN SHALL BE DETERMINED UPON FINAL CONFIGURATION OF TRAIL DESIGN OR AS APPROVED OTHERWISE BY THE ENGINEER OR THEIR DESIGNATED REPRESENTATIVE.
