ANALYSIS / ADDITIONAL INFORMATION: City Council increased funding for homelessness efforts in the FY 2018-19 budget by \$3.5 million, in addition to the approximately \$26.0 million of homelessness-related funding already included in the budget for contracts and other staff efforts. Council approved an additional \$1.0 million dollars, allocated to the Austin Public Health budget. This ordinance transfers \$694,733 of the \$1.0 million from Austin Public Health's Operating Budget as follows, with \$305,267 remaining in the Austin Public Health operating budget:

Emergency Medical Services: \$193,602 (\$100,503 in one-time costs and \$93,099 in ongoing costs) for a Clinical Specialist position, vehicle, and vehicle fleet and maintenance. Funding for one-time items will revert to the Austin Public Health budget in FY 2019-2020.

Municipal Court: \$313,643 within Downtown Austin Community Court for a Clinical Case Manager position, direct services funding, and Rapid Rehousing funding.

Austin Police Department: \$187,488 for ARCH security.
