NRD-2018-0062 1206 W. 10th Street West Line Historic District

PROPOSAL

Demolish a ca. 1910 house.

ARCHITECTURE

Cross-gabled, T-plan house clad in wood, with 2:2 and 1:1 double-hung wood-sash windows and a half-width porch.

RESEARCH

The house was constructed around 1910. Two families have occupied it for sustained periods of time: James and Wilhelmina Turpen (ca. 1918-35) and Edward and Sadie Harris (ca. 1940-59). James Turpen worked for two decades as a captain at the fire station just down the block, while Edward Harris worked as a tile layer. After the Harrises moved out, the house was occupied by a succession of renters.

The house appears to remain in its original form, and no major changes are noted in building permits for the property. Renters were listed alongside owner-occupants in city directories beginning around 1929, but they were members of the owner's family. From around 1937, renters who were not family members are listed in directories. By 1973, the separation had been formalized as units A and B.

STANDARDS FOR REVIEW

The property is contributing to the West Line Historic District. It does not appear to meet the standards for designation as a historic landmark.

Designation Criteria—Historic Landmark


- 1) The building is more than 50 years old.
- 2) The building appears to retain a high degree of integrity.
- 3) Properties must meet two historic designation criteria for landmark designation (City of Austin Land Development Code (Section 25-2-352). The property does not appear to demonstrate significance according to any of the criteria.
 - a. **Architecture.** The building is a good example of the National Folk style. It does not appear to be architecturally significant.
 - b. **Historical association**. James and Wilhelmina Turpen and Edward and Sadie Harris each lived in the house for approximately 20 years. There do not appear to be significant historical associations.
 - c. **Archaeology**. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - d. **Community value**. The property does not appear to possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the community, Austin, or Texas as a whole.
 - e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use of the existing building, including consideration of a demolition delay, as the building is contributing to the historic district. If the Commission votes to approve the permit, then staff recommends completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.


Due to the building's location in a National Register historic district, the Commission must review and comment on the proposed plans for new construction prior to the release of the demolition permit. No plans have been received to date.

Background Research

James Aron Turpen lived at 1206 W. 10th Street from at least 1918 until his death in 1927, with one break in the mid-1920s. Born in 1877 in Texas, James Turpen grew up in a farming family in Montague, just south of the Oklahoma border. He worked for 20 years as the captain of Engine Company No. 4, located at the end of the 1200 block of W. 10th Street. He was promoted to fire inspector just before he died of pneumonia in 1927.

TURPEN DIES

Fire Inspector Succumbs to Pneumonia

James A. Turpen, 49, city fire inspector, died at 7 o'clock Saturday morning at his home, 1206 West 10th street, following an illness of pneumonia. Mr. Turpen had been ill since Jan. 5.

Mr. Turpen, familiarly known to his associates in the fire department as Captain Turpen, was captain of Engine Company No. 4, West Austin fire hall, for 20 years. He was transferred from this post on Jan. 1 to fire inspector to succeed Arthur Woody, who resigned to become constable.

Mr. Turpen was born Nov. 21, 1877 and is survived by his widow and four children, Joe F. Turpen, James A. Turpen, Jr., Richard Turpen and Charles Turpen, all of Austin; his mother, Mrs. Mollie Turpen of Austin; four sisters, Mrs. T. W. Roper, Mrs. B. F. Hall, Mrs. Louise Lowery, all of Fort Worth, and Mrs. Tom Matt, of Ardmore, Okla.

Funeral services will be held at 4:30 Sunday afternoon at St. Mary's church with the Rev. Michael Quinlan officiating. Interment will be in Mount Calvary cemetery.

SERVICES FOR TURPEN TODAY

Fire Department Employe Is Dead.

Funeral services for J. A. Turpen, 48, who died at his home, 1206 West Tenth street, Saturday morning, will be held from St. Mary's Catholic church Sunday afternoon at 4:80 o'clock with the Rev. Father Quinlan officiating. Burial will be at Mount Calvary cemetery. Mr. Turpen was an employe of the city fire department forces.

Mr. Turpen is survived by his widow and four sons, Joe F. Turpen, James A. Turpen Jr., Richard Turpen and Charles Turpen. He is also survived by his mother, Mrs. Mollie Turpen of Austin; four sisters, Mrs. T. W. Roper, Mrs. B. F. Hall, Mrs. Louise Lowery of Fort Worth and Mrs. Tom Mapp of Ardmore, Okla.

Active pallbearers will be: Lee Maufrais, Jack Mangham, Ed Allen, Henry Wendlandt, Harvey Maddox and L. H. Ward.

Honorary pallbearers will be: Adam R. Johnson, John Woody, George W. Mendell Jr., C. A. Maufrais, J. L. Loudin, W. D. Shelly, Rufus Voss, W. E. Babel and Robert Barker. Wilhelmina Turpen lived in the house from at least 1918 until about 1935, with two breaks in the mid-1920s and early 1930s. Born Wilhelmina Krahe around 1879 in Germany, she immigrated to the United States at an unknown date. By 1898, she was living in Travis County, where she married James Turpen. The couple had six children, four of whom survived. After James Turpen died in 1927, Wilhelmina may have remarried, as her obituary lists her name as Wilhelmina Jennings (perhaps coincidentally, the surname of the family that occupied 1206 W. 10th Street by 1940, a few years after she moved out). She died in 1961 in San Bernadino, California.

Mrs. Wilhelmena Jennings, 79, of San Bernadino, Calif., died in that city Wednesday. She was a former resident of Austin and was a member of the Catholic Church. Survivors include three sons, Joe Turpen of Eagle Pass, James A. Turpen of San Antonio and R. K. Turpen of Victoria; 14 grand-children and 18 great grandchildren.

The body will be received in Austin Surday by the Hyltin-Manor Funeral Home.

Edward Lee ("Edd") Harris lived in the house from at least 1944 until around 1959. He was born in 1882 in Texas to a large farming family and grew up helping on the farm. As an adult, he worked as a tile helper for a few floor covering companies in Austin. Edward Harris died in 1965 in Travis County.

Sadie Beth Harris (nee Henderson) was born in 1896 in Pulaski, Tennessee. By the time she was 14, her family had moved to Texas and settled in Buda. Sadie married Edward Harris by 1913, and the couple had at least two children. Prior to moving to 1206 W. 10th Street, in 1940, the Harrises rented a house at 601½ W. 6th Street, housed Edward's father and Sadie's mother, and had a lodger, a 33-year-old divorced woman. Newspapers in 1942 mention the family as living in Manor. Sadie Harris died in 1972 in Austin.




