# Minutes Parks and Recreation Board November 19, 1991

#### CALL TO ORDER

#### CITIZENS COMMUNICATIONS

- 2. Additional Recreation Centers, Inner City Park Needs, Ballfields, and
- 3. Town Lake and Colorado River Park.

Neil Iscoe moved and Ron Cartlidge seconded a motion to send the following resolution to the Austin City Council.

WHEREAS, it is imperative that the Texas Parks and Wildlife Department grant funding process be clarified as quickly as possible; and

WHEREAS, the continued failure of Circle C Development Corporation to honor its commitments on the Veloway jeopardizing all of the City's Texas Parks and Wildlife Department grant applications;

THEREFORE, BE IT RESOLVED, that the City of Austin withdraw its participation in the Veloway project; and

Use the \$318,000 in Bikeway funds for other bike related projects; and

That whatever steps appropriate be taken to make sure that the Dove Springs Pool open in the Summer of 1993 and that the Dick Nichols Park be open at the same time or as soon as possible afterwards.

The motion passed unanimously.

Approval of construction of restrooms at the Kreig Softball Complex

Eliza May moved and James Crump seconded a motion to allow the transfer of funds from the Softball Enterprise Fund to the CIP account for construction of additional restroom facilities at the Kreig Softball Complex. The motion passed unanimously.

There being no further business, the meeting stood adjourned.
