Attached for your information is an updated project list. We have completed new or revised estimates for some projects. In addition, Boards and Commissions have recommended several projects not previously on the project list, and those new projects have been added.

BOARDS AND COMMISSIONS RECOMMENDATIONS

We have provided the Planning Commission CIP Subcommittee with the detailed recommendations received to date from Boards and Commissions. The Citizens' Bonds Advisory Committee (CBAC) will receive this information at the February 26 meeting. All CBAC notebooks will be updated with this information, as well. We will continue to keep you informed as new recommendations are received.

PUBLIC MEETING SCHEDULE/PUBLICATION

The Planning Commission will hold three public hearings as they consider their recommendation for the 1998 bond election. Those hearings are scheduled for March 17, March 24, and April 7. They have requested that the March 17 hearing be devoted to all projects with the exception of Parks and Recreation projects, and March 24 be devoted to all projects except Library projects. They will have a recommendation from the Planning Commission subcommittee by the time they hold the April 7 public hearing.

Subject: Disc Golf Concession Management

At the February 24, 1998 Parks and Recreation Board Meeting, I have scheduled a public hearing concerning the possibility of a permanent management concession for the Disc Golf Courses. Disc Golf is growing rapidly in popularity across the nation, and we are trying to put some controls in place before it gets out of hand. The City has five courses in our Park system: Bartholomew, Zilker, Pease, Slaughter Creek, and Mary Moore Searight.

Some of the concerns of Disc Golf are litter, vandalism of the baskets, and turf erosion. If the courses were operated as a concession, the contractor would be responsible for continual trash pick up, better security of the area, maintaining the baskets, closing the courses on rainy days, and changing the position of baskets periodically to reduce erosion. Another benefit to the City is revenues from this concession.

I encourage you to consider this information, along with the public input at this hearing and make a recommendation at the March 10, 1998 Parks Board Meeting.

SUBJECT: Proposed Annexation by Moore's Crossing MUD

Staff have reviewed the attached request by developers of Moore's Crossing MUD to annex the 18-acre Galloway out tract. Due to the location of the tract, it makes perfect sense for the MUD to annex and serve it. The attached memorandum explains the history of the tract.

The annexation action would add 6.5 acres of new single family residential development to the overall MUD project. The proposed development would roughly translate into an added resident population of about 90 people and a parkland requirement of less than 1 acre. The almost 105 acres of parkland shown for dedication on the MUD's Land Plan already exceeds requirements, even with the Galloway out tract additions, by about 45%, so the annexation would generate no new park or recreation facility requirements.

I have no objection to the proposed annexation of the Galloway tract into Moore's Crossing MUD.
