**Parks Board Minutes  
June 8, 1999  
Regular Meeting**

A regularly scheduled meeting of the Parks and Recreation Board was held on Tuesday, June 8, 1999, in the PARD Main Office, BoardRoom at 200 South Lamar Boulevard.

**A. MEETING CALL TO ORDER**

**E. ITEMS FOR ACTION**
