E. ITEMS FOR ACTION

- 1. Approve Construction of Woods Boat Dock at 1109 N. Weston Lane. There was brief discussion regarding this item, it is a re-model of one slip. Mary Ruth Holder made a motion that the board approves this item. Jeff Francell seconded. The vote of approval was 5-0-0 (Librik, Holder, Carter, Francell, Cruz-Torres).
- 2. Approve Construction of Batlin/Allison Boat at 4500 Waterford Place This item was pulled.
- 3. Approve Construction of Eisenberg Boat Dock at 4107 Lake Place. Jeff Francell made a motion for approval of the Eisenberg Boat Dock at 4107 Lake Place. Mary Ruth Holder seconded the motion. After brief discussion, regarding city code, the vote of approval was 3-2-0 (Holder, Francell, Cruz-Torres) (Librik, Carter).
- 4. Approve Construction of McCarthy Boat Dock at 12021 Selma Hughes Park Road. Jeff Francell made a motion that the Board recommends the McCarthy Boat Dock be constructed. Mary Ruth Holder seconded the motion. The vote of approval was 3-2-0 (Holder, Francell, Cruz-Torres) (Librik, Carter).

F. DIRECTOR'S REPORT

Mr. Olivares spoke regarding a question that was raised at the Parks Board meeting that was held on May 25, 1999, regarding free swim hours at Barton Springs Pool. Mr. Olivares explained that a lot of kids were coming in by 8:00 a.m. unsupervised and this was creating some safety issues. There will now be an extra hour in the evening where swimmers can swim free. Mr. Olivares also mentioned that automated doors will be installed during the winter that will open with a clock, for example, at 5:00 a.m., the doors will automatically open. Mr. Olivares mentioned that in the Barton Springs area, the Robert E. Lee section of road is open. There is some trail work being done in this area as well. Movie nights have started for the Aquatics Division, they are being held every Saturday at Deep Eddy Pool. Also, the opening ceremonies for playgrounds will be held tomorrow (June 9, 1999) at 10:00 on Auditorium Shores. Mr. Olivares gave an update on the Rowing Center; staff will continue to work with the owners

regarding a site plan. Two top candidates have been interviewed for the position of Division Manager of Cultural Affairs; a decision will be made sometime in July. Mr. Olivares announced that the City of Austin, after about three years, has purchased 100 acres around William Cannon/Pleasant Valley; destined to be developed as a soccer complex.

G. COMMITTEE REPORTS

Programs Committee-a written summary of the meeting was handed out. **Land and Facilities Committee-**a summary of the special called meeting was handed out. Elaine Carter asked that it be noted that a fenced area for the perimeter was requested. Mr. Olivares offered a monthly status report on this project.

Municipal Airport Advisory Group – there were two handouts. One the first handout, a memorandum to the RMMA Redevlopment Advisory Group, some issues relating to parks are found on page 3, encourage certain interim uses. Also on page 4 and 5, encourage the development of large and small parks, and page 7 phasing. Also, there was a handout on tunnels versus bridges. Mike Librik also stated that the project is up in the air at the moment. There will be an interim use for a while longer.
