- 1. Citizens Communication None
- **2.** Chair and Vice-chair Elections Peter Torgrimson elected as Chair. Laurie Dries elected as Vice Chair. Motion by Neely for appointment by acclamation. Seconded by Hegemier. No objections. Both passed unanimously.
- **3. Approve Record of Decision from 10/24/2017** Whatley made a motion to approve, seconded by Hegemier, carried 7/0 with one abstention (Schmitt)
- Draft Welcome Packet for CAC Members Secretary reviewed draft CAC welcome
 packet with CAC members. The purpose of the packet is to provide information about
 the BCCP. CAC members have two weeks to submit comments and edits for final
 version.
- 5. CAC Member Updates Secretary reported that there are two new CAC members. Amy Belaire was appointed by Travis County in February, and Fred Morgan was appointed by the Parks and Recreation Board. The Advisory Committee Task Group has begun the member replacement process for the vacant Consensus Environmental Interests seat. Ken Beck resigned from the CAC on April 11th. He was a Travis County appointee, so Travis County Commissioners Court will be responsible for selecting another CAC member.

6. BCP Partner Reports Q&A BCP partner reports were distributed ahead of the meeting for CAC review and BCP Staff were present to answer questions.

7. Current Topic Discussions

- a. Members' issues and concerns Members discussed BCP related community issues of concern, including fencing, wildfire, and species delisting, and talked with BCP staff about the possibility of creating informational pamphlets. Members also discussed challenges facing the BCP and the benefits that a Friends of the BCP group could potentially have on public support of the preserves.
- b. Upcoming BCCP Land Management Plan Revision Reviews Secretary reported that BCP staff are working on the revision of the draft Public Access chapter and the Fire Management chapter. Both chapters will be sent to the CAC for review and comment, and the timing may be outside of your regular meetings. The review would be considered a committee task. BCP staff are working on the first draft of the fire management chapter update. It will go to BCP Partners and the CAC and SAC for a review and comment period. After that review and revision, it will be publicly posted with an option for public online comment submission. The comments will be compiled, and the draft chapter and comments will be presented to the Coordinating Committee for review.
