PROPOSAL

Demolish a one-story house built ca. 1940.

ARCHITECTURE

One-story, cross-gabled, L-plan house built in the Minimal Traditional style; clad in brick siding. Windows are not visible due to screens.

RESEARCH

The house was constructed around 1940. Caspar “C. J.” and Laura Schmid were the longest-term residents, living in the house from around 1944 until at least 1992. Caspar worked as a farmer and manufacturer’s representative, while Laura worked in the Systems Administration Department at UT.

STANDARDS FOR REVIEW

The house is a contributing property in the Old West Austin Historic District. It does not appear to meet the standards for designation as a historic landmark.

Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old, having been constructed ca. 1940.
- 2) The building appears to retain a high degree of integrity.
- 3) Properties must meet two historic designation criteria for landmark designation (City of Austin Land Development Code (Section 25-2-352). The property does not appear to demonstrate significance according to any of the criteria.
 - a. **Architecture.** The building is an intact example of the Minimal Traditional style, but does not appear to be architecturally significant.
 - b. **Historical association.** Caspar and Laura Schmid lived in the house for at least forty years. However, there do not appear to be significant historical associations.
 - c. **Archaeology.** The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - d. **Community value.** The property does not appear to possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the community, Austin, or Texas as a whole.
 - e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION




Encourage rehabilitation and adaptive re-use of the existing building, including consideration of a demolition delay, as the building is contributing to the historic district. Encourage relocation over demolition. If the Commission votes to release the demolition permit, then staff recommends completion of a City of Austin Documentation Package,

consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

Due to the building's location in a National Register historic district, the Commission must review and comment on the proposed plans for new construction prior to the release of the demolition permit. No plans have been received to date.

Background Research

Caspar (spelled Casper in city directories) “C. J.” Johann Schmid was born in 1903 in Glarus, Switzerland. He immigrated to the U.S. as a student in 1929, entering through

Brownsville, Texas. He worked as a cotton exporter and salesman for David C. Reed in the 1930s, then as a farmer and manufacturer's representative later in his career. He co-founded and served as president of the Capital Area Farm and Ranch Club and was also an active champion of the polio vaccine, serving as vice chair of the Travis County Foundation for Infant Paralysis in 1957. Schmid retired by 1973 and died in 1990 in Austin.

AUSTINITE FINDS WORLD SMALL IN UNIVERSE'S LARGEST CITY

WASHINGTON, D. C., July 28.—“I think that man might be my brother,” C. J. Schmid, 2513 Jarratt in Austin, told his wife at LaGuardia Airport as she waited to board a plane for Switzerland.

Sure enough it was.

And so Schmid, who hadn't seen his twin brother for 20 years, was united with him in a surprise meeting in the largest airport in the largest city in the world.

Schmid, an associate of Dave Reed in Austin, has corresponded with his twin, Eugene, and his father (both of whom still live in Switzerland) ever since he left 20 years ago.

Pictures have been sent of Schmid's three-year-old son, John David. This summer Schmid de-

cided that his son and wife would visit his family so he brought them to New York to put them on a plane last week.

The plane was 30 minutes late. During that time a plane from Switzerland arrived. Eugene Schmid, who was on a sudden and unexpected business trip to New York, arrived and walked through the airport. He spied a child that looked familiar. The more he looked at it the more it looked like his brother C. J.'s boy in Austin.

As the man stared, he attracted the attention of the child's father. The more the father looked at the man, the more he looked like his twin brother.

He mentioned this to his wife and then asked the stranger, “Are you looking for something particular?”

The man started blabbering in Swiss. C. J. had forgotten all the Swiss he knew but he used sign language and a few words that

came back to him. It didn't take long to figure out the relationship. So after putting Mrs. Schmid on the plane the brothers got together for a real celebration in the biggest little town in the world!

Forty-seven-year-old Schmid went to Austin in 1928 from Glarus, Switzerland.

He was a partner in C. R. Fix and Company at Austin, a cotton exporting firm, until about eight years ago when the firm was dissolved.

Long associated with the cotton world, he spent a number of years in India for a Swiss firm before going to Texas.

Caspar Johann (C.J. Schmidy) Schmid, age 87, of Austin, Texas, died Saturday, October 6, 1990.

He was born in Glarus, Switzerland, and had resided in Austin since 1929.

He was one of the founders and past presidents of the Capital Area Farm and Ranch Club, a charter member of the Headliners Club, a charter member of the West Austin Rotary Club, and was a recipient of the Paul Harris Fellowship from the Rotary Club, a member of the Ben Hur Temple, a charter member of the Austin Elks

Lodge, a member of the Woods and Water Club and the Power Squadron, and past president of the Austin Chapter of the March of Dimes.

Mr. Schmid is survived by his wife, Laura Frances; daughter, Margo Beltran of Houston; daughters and sons-in-law, Laurie and Frank Perez of Brownsville, and Libby and Wes Martin, of North Carolina; and two grandchildren, Jon and Laura Martin.

Graveside services will be held at 11:00 AM, Thursday, in Austin Memorial Park.
