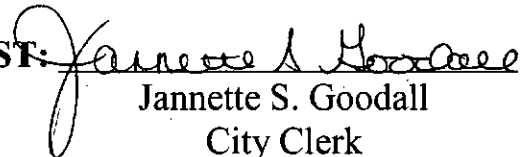

RE: Request for Amendments to Sobering Center By-Laws and Articles of Incorporation

Dear Honorable Mayor and City Council:

On October 10, 2018 the Board of the Sobering Center voted to request amendments to both the By-Laws and Articles of Incorporation of the Local Governmental Corporation.

We request a change to our By-Laws, Article 2 Board of Directors, 2.9 Committees. The current language is as follows:  
*The Board may, by resolution passed by a majority of the directors, designate three (3) or more directors to constitute an executive committee or other type of committee.*

Currently the Board has created 6 committees: Executive, Development, Governance, Finance, Community Engagement, and Ad Hoc Strategic. As the By-laws are currently written board members would have to serve on multiple committees as well as the general board. As a volunteer board this is unworkable. Non-profits frequently include staff, ex-officio and community members on committees as a way of gaining special expertise and giving community members an opportunity to contribute the success of their mission. Thus we would like to eliminate a requirement of at least 3 board members on each committee. Here is the language we recommend:

*The Board may, by resolution passed by a majority of the directors, create committees constituted of directors, ex-officio directors, staff or qualified members of the community.*

We request a change to the Articles of Incorporation regarding the length of terms for current board members as well as current terms expiration dates for both board members and the two elected officials who serve on the board. Currently the language is set forth in Article VI. Board, in the first paragraph:

*his or her successor is appointed, unless such Director has been appointed to fill an unexpired term, in which case the term of such Director shall expire on the expiration date of the term of the Director who he or she was appointed to replace. Initial Directors and succeeding Directors may be reappointed. Each initial Director and each succeeding Director may serve for a maximum of **eight** years as a Director.*

We are concerned that every four years half of our board membership will change. Additionally a four year term is a long commitment. We recommend that board terms be 3 years and the 9 board directors' terms be staggered so that no more than 3 board members change at a time. We believe a 9 year maximum is necessary as some current board members who renew for three years will end up serving 7 years. This ensures current board members have the opportunity to serve another term as anticipated in the original Articles. The language would change to read as follows:

*Each other subsequent Director, each of whom must reside in the city and the County or solely within the County, shall serve for a term of **three** years or until his or her successor is appointed, unless such Director has been appointed to fill an unexpired term, in which case the term of such Director shall expire on the expiration date of the term of the Director who he or she was appointed to replace. Initial Directors and succeeding Directors may be reappointed. Each initial Director and each succeeding Director may serve for a maximum of **nine** years as a Director.*

Change would also occur under ARTICLE IX INITIAL BOARD

Within the chart listing the initial board the terms, expiration dates would be amended as follows:

Position 7: City, Reginald Smith (initially Deborah Hiser), September 30, **2022**  
Position 7: County, William Brice, September 30, **2021**  
Position 9: Joint, Andy Brown, September, **2022**  
Position 10: City Councilmember, Katheryne B. Tovo, **December 31, 2020**  
Position 11: County Commissioner, Margaret Gomez, **December 31, 2020**

We also have an issue with the officers' terms of two years. Our first board meeting occurred in November of 2016. While I was appointed board chair the other officers were not elected until our first annual meeting in January 2017. If we hold officer elections in January 2019 under a two year term requirement then some officers elected will have their board terms end before the officer term ends. We believe that the City Council and Commissioner's Court will understand if these initial terms for officers end on September 30 2019. In the alternative the City Council and Commissioner's Court could change all board terms to end on December 31<sup>st</sup>, rather than September 30<sup>th</sup>.
