Amount and Source of Funding	
Funding is available in the Fiscal Year 2018-2019 Operating Budget of Austin Water.	
Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) 2200 GLB1015 for these goods. The solicitation issued on January 14, 2019 and it closed on February 5, 2019. Of the two offers received, the recommended contractor submitted the lowest responsive offer. MBE/WBE:	This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established.

The contract is to purchase five phase separator dewatering roll-off containers for Austin Water. The containers are 25 cubic yard phase separator dewatering hard top steel roll-off containers with filters. These containers are an essential part of dewatering sludge, clarifying liquids, phase separation, material recovery and the septage dewatering process of waste and sludge. They are utilized 24 hours a day, seven days a week to maintain compliance of landfill disposal regulations.

This purchase will replace existing containers that have been welded and repaired numerous times. The current containers have reached their end of service life.

PRICE ANALYSIS

- a) Solicitations: 55 notices were sent, including 2 MBE and 0 WBE firms, 2 responsive bids were received with no M/WBE firms responding.
- b) Cost Analysis: Compared to the last purchase of this item in 2012, the cost for this product increase by 33%. Since 2012 the index supports a 45% increase, and shows that the industry will continue to have increases throughout 2019.
