# HISTORIC LANDMARK COMMISSION APRIL 22, 2019 DEMOLITION AND RELOCATION PERMITS HDP-2019-0148 3903 PETE'S PATH

#### **PROPOSAL**

Demolish a ca. 1949 house and detached garage.

#### ARCHITECTURE

One-story, irregular-plan, hipped-roof frame house with a projecting front bay with a hipped roof containing a fixed-sash picture window with two flanking sash windows; partial-width inset porch with an ornamental metal support.

### RESEARCH

The house was built in 1949 by Meredith H. "Babe" Green and his wife, Snowdy. Babe Green was a mail carrier for the Post Office. He and Snowdy lived here until around 1953, when they moved to a house on Ridgehaven Drive. Rev. Robert D. and Betty R. Lovell purchased the house after the Greens moved, and lived here until Rev. Lovell accepted a pastorship at a university-related church in Champaign, Illinois in 1959. While in Austin Rev. Lovell was the assistant pastor at the University Baptist Church. From around 1963 until around 1972, the house was owned and occupied by Leroy and Isabella Hinze, formerly of Bartlett, in Williamson County, Texas. Leroy Hinze was an attendant at Austin State School. He passed away in 1974. There has been a series of short-term renters and owners in the house since the 1970s, none with an occupation shown in the city directory listings.

### STAFF COMMENTS

The house is beyond the scope of any City survey to date.


Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a post-World War II cottage with a boxy composition and little architectural distinction. The house is somewhat of an anomaly in the Ridglea neighborhood, which features more traditional styles of post-war design and construction.
- b. **Historical association**. The house reflects ownership and occupancy by middleclass families, including that of a mail carrier, an assistant minister, and an attendant at the Austin State School. There do not appear to be significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

### STAFF RECOMMENDATION


Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

His 1940 World War II draft card shows that Meredith Henry Green was born in Tracy, Texas in 1918 and was unemployed. He was 5'-9", weighed 155, and had a ruddy complexion with black hair and gray eyes.

Meredith Henry Green married Snowdy Caffey in Travis County in 1941.

Meredith Henry Green's 1971 death certificate shows that he was living at 1600 Ridgehaven Drive at the time of his death. He was born in Texas in 1918 and was employed by the U.S. Post Office. Snowdy Selita Caffey Green was born in Rockdale, Texas in 1918 and died in Austin in 2009.

### M. H. (BABE) GREEN

M. H. (Babe) Green, 53, of 1600 Ridgehaven, died Monday in a local hospital. He had been a resident of Austin and Travis County for the past 24 years and was an employe of the Post Office.

He was a member of Hill City Lodge No. 456 A.F.&A.M., the National Association of Letter Carriers, and was a Deacon of Windsor Park Baptist Church.

Kentucky and was an insurance salesman. Virginia Lovell, 40, was born in Mississippi and was a seamstress.

Robert Daniel Lovell's 1945 World War II draft card shows that he was a student at SMU and living in Dallas. He was born in Chicago, Illinois in 1927. He was 5'-10", weighed 155 pounds, and had a ruddy complexion with black hair and blue eyes.

Following their residence in this house, Robert D. and Betty Lovell moved to Champaign, Illinois, where he became the pastor of a church there.

Leroy G. Hinze appears in the 1930 U.S. Census for Williamson County, Texas as the 13-year old son of August and Martha A. Hinze, who owned their farm on the Bartlett and Wahlberg Road. Leroy G. Hinze was born in Texas and had no occupation listed. He was the youngest of August and Martha's 7 children. August Hinze was a 62-year old Texas-born farmer whose parents had

been born in Berlin, Germany. Martha Hinze, 56, was born in Saxony, Germany and had no occupation listed.

His 1940 World War II draft card shows that Leroy Gus Hinze was born in Williamson County, Texas in 1916 and was living in Bartlett, Texas, where he worked for a grain company. He was 5'-7", weighed 205 pounds and had a ruddy complexion with black hair and brown eyes.

Leroy Gus Hinze's 1974 death certificate shows that he was living in Pflugerville, Texas at the time of his death. He was born in 1916 in Bartlett, Texas and was retired from Austin State School. Isabella Hinze was born in 1917 in Bartlett, Texas and died in 2004. Both are buried in the Bartlett City Cemetery.
