<u>SUMMARY STAFF RECOMMENDATION</u>: Staff recommends the proposed zoning change from single family residence, neighborhood plan (SF-3-NP) combining district to single family residence – Historic Landmark – neighborhood plan (SF-3-H-NP) combining district zoning if the Commission accepts that the criterion for historical significance is squarely met with only a 2-year span of the historic period.

Staff has evaluated this house for designation as a historic landmark and has determined that the house meets the criterion for architecture for its excellent reflection of Colonial Revival architecture, but presents a less strong case for historical associations within the historic period:

- a. **Architecture.** The house is an excellent example of Colonial Revival architecture with its symmetrical composition, multi-light windows, and differentiation between the first and second floors. The house clearly meets the criterion for architecture.
- b. **Historical association**. The house was built by an insurance executive and his family, who lived here until 1967; the next owner of the house, Ernest E. Smith, III, is an authority on oil and gas law in Texas, and has served as a professor and dean at the University of Texas School of Law. However, Professor Smith's association with the house began around 1967 and consists of only 2 years within the historic period for the house.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

Staff believes the house will qualify as a historic landmark if the Commission views the historical association of Ernest Smith as significant enough to over-ride the fact that his association was only for 2 years within the historic period. This house is a classic example of Colonial Revival architecture, and will have historical significance in the future as the tenancy of Ernest E. Smith, III ages into the 50-year historical period. If the Commission

does not recommend historic zoning with this understanding, then staff encourages rehabilitation and adaptive re-use, then relocation over demolition, and completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

PLANNING COMMISSION ACTION:

DEPARTMENT COMMENTS: The house is beyond the bounds of the Comprehensive Cultural Resources Survey (1984).

On April 22, 2019, the Commission requested that staff provide information about garden suburbs, as described by several speakers at the public hearing, to determine whether the Leach-Smith House represents a Garden Suburb movement in the Westfield "A" subdivision of which it is a part. The Leach-Smith House, like many other houses in the neighborhood, is sited on a large lot, larger than most urban lots in Austin. Westfield "A" had a number of large lots, but the reason for the size of the lots is not defined by the subdivision documents.

Garden suburbs were an outgrowth of the British "Garden City" movement of the 1880s and 1890s. As envisioned by Sir Ebenezer Howard, a "garden city" was one that captured the amenities of the city, but was surrounded by a "greenbelt" that preserved agricultural uses on the edge of a city. Howard was concerned about the suburban sprawl of London in the late 1800s and his "garden city" model was designed to end land speculation on the outskirts of a city through controlling the use of land and incorporating agriculture into the model for a successful suburban settlement.

The "Garden City" movement eventually made its way to the United States, and land on the outskirts of several large American cities were transformed into garden cities, including Shaker Heights, near Cleveland, Ohio, Residence Park in New Rochelle, new York, Forest Hills Gardens in Queens, New York, Chatham Village in Pittsburgh, and others. In the 1930s, the United States Resettlement Administration planned some garden city communities, including Greenbelt, Maryland near Washington, D.C., Greendale, Wisconsin, and Greenhills, Ohio. These garden cities were intended to provide affordable housing in a relatively self-sufficient environment, with easy access to a city and the preservation of the agricultural countryside as the guiding philosophical tenets of the urban design.

Garden suburbs, as opposed to garden cities, were not designed to be economically selfsufficient as promoted by Ebenezer Howard. Garden suburbs were developed along two models, what has been described as a garden village, and a garden enclave. Garden villages generally contained more features of the garden city movement in that they had urban amenities, such as shops, civic buildings and institutions such as libraries, and the focus of the design was on public spaces. Garden enclaves, on the other hand, were exclusively residential and centered on private or undeveloped spaces. The emphasis in both, however, was a conscious design to adopt some of the tenets of the garden city movement but without the economic self-sufficiency and reins on land speculation that the proponents of the garden city promoted.

Architecture:

Two-story, rectangular-plan, side-gabled Colonial Revival-styled frame house with stone veneer on the first story; single and paired Colonial Revival-styled windows with an 8:8 configuration; pilasters at the sides of the central front entry, which has a shed=-roofed hood over the door; the integral garage to the right of the principal block of the house has a second story with single 1:1 fenestration.

Historical Associations:

The house was built in 1940 by John I. Leach and his wife, Thelma, who went by Molly. John I. Leach was an insurance executive who headed up the district offices for several life insurance companies during the course of his career. He and Molly lived here from the time of the construction of the house in 1940 until around 1967.

From 1967 to the present, the house has been owned and occupied by Ernest E. Smith, III and his wife, Paula. Ernest E. Smith is a professor of oil and gas law at the University of Texas School of Law and served as the dean of the law school. He has also authored several texts on oil and gas and natural resources law, and has been a visiting professor of law at several schools throughout the country as well as the University of Dundee in Scotland.

Subject: History of Residence at 1400 Winsted Lane, Austin, Texas

My wife and I acquired the residence at 1400 Winsted Lane in 1967, having admired the house and neighborhood and desiring to raise our family there. We continued to live there with our two sons, Brian and Carter, until approximately 2003.

With some minor additions, the house remained as we had acquired it from the original family, who had built it in the 1930's. The neighborhood experienced some change, but for the most part it was a four to six block area with many young families and established residents. During the period of our ownership, the building of Mopac started to take place and with the aid of a number of neighbors, we were all able to persuade the City of Austin that not concreting over Johnson Creek and keeping the east side of Winsted as a green area connecting West Enfield Park to Lady Bird Lake would be the most desirable result. As city hike and bike trails have developed, this has been an important corridor. Additionally, zoning requirements in the West Enfield Subdivision have been monitored and actively supported.


During the time of our ownership, I succeeded Page Keeton as Dean of the University of Texas Law School and my wife and I frequently entertained law school faculty, visitors and foreign dignitaries, including the Chief Justice of Nicaragua. On several occasions, faculty and students from the University of Guanajuato, Mexico were guests. These visits fostered international relationships for the University of Texas law school. My wife, an attorney, and I used office space within the house for our professional careers, and several casebooks and treatises were part of my work product there.

During our history with 1400 Winsted, Winsted Lane has been the eastern boundary of the West Enfield subdivision's pleasant and discrete mainly single family residential neighborhood. While we no longer live in the house, my wife and I strongly support all efforts to keep the subdivision as an historic residential area serving the University of Texas and providing an alternative to high density development rapidly overtaking all of Central Austin.


For all of the above reasons, my wife and I urge you to designate 1400 Winsted Lanc as an historic landmark property and to deny the demolition request.

Ernest E. Smith, III and Paula Smith (ca. 1967 -)

Ernest E. Smith, III is the Rex G. Baker Centennial Chair in Natural Resources Law at the University of Texas School of Law. He was born in Gonzales, Texas in 1936 and received his

B.A. from Southern Methodist University in 1958. He graduated from Harvard Law School in 1962. He has been a professor of law at the University of Texas since 1968 and has served as a visiting professor at law schools throughout the country and internationally, including the University of Maine, Harvard Law School, the University of Dundee in Scotland, the University of Colorado and the University of Minnesota. He is a specialist in oil and gas law and has authored several textbooks, including <u>Cases and Materials on the Law of Oil and Gas</u> (1954), <u>Texas Law of Oil and Gas</u>, and <u>Texas Wind Law</u>. He has been the Rex G. Baker Centennial Chair in Natural Resources Law at the University of Texas since 1983. He is married to the former Paula Young.

A specialist in oil and gas law, Professor Smith is co-author of the leading casebook on Oil and Gas Law (West, 6th ed., 2013), and the leading treatise on Texas Law of Oil and Gas (3 volumes, 2nd ed., LEXIS, 1998). Other co-authored books on oil and gas law include Hemingway Oil and Gas Law and Taxation (4th ed., 2004), and International Petroleum Transactions (3rd ed., 2010). He is also co-author of Cases and Materials on Property (Foundation, 9th ed., 2007) and (Texas) Wind Law (Lexis 2011).

In 2008 Professor Smith received the Massey Teaching Excellence Award. Earlier teaching awards include the Clyde Martz Award for Excellence in Teaching from the Rocky Mountain Mineral Law Foundation in 1998, and the Texas Excellence Teaching Award for the School of Law from the Ex-Students Association in 2000. In the same year, Annual Institute of Oil, Gas and Mineral Law, which is co-sponsored by the Texas State Bar Section on Oil, Gas and Energy Law and the University of Texas School of Law was re-named the Ernest E. Smith Oil, Gas and Mineral Law Institute. The Ernest E. Smith Endowed Presidential Scholarship in Law was established in 1994, and the Ernest E. Smith Professorship in Law was established in 1996.

Professor Smith teaches classes in the areas of property, oil and gas, international petroleum transactions, and wind energy law. A former Dean of the Law School, Professor Smith has also been a Visiting Professor at several law schools including Harvard.


