MINUTES

On Commissioner Azhar's motion, Commissioner Hinely's second, the CDC approved the recommendation that the total membership of the CDC remain at 15 members on a 8-3 vote. Commissioners Dailey, Delgado, and McGhee opposed.

On Commissioner Azhar's motion, Commissioner McGhee's second, the CDC approved the appointment of a representative of Travis County to serve on the CDC, selected from the Del Valle area, by the Health and Human Services Committee or Housing and Planning Committee of City Council on a 10-1 vote. Commissioner Hinely opposed.

On Commissioner Paup's motion, Commissioner McGhee's second, the CSBG designated geographic areas were unanimously approved to be changed based on the APH recommendations.

On Commissioner McGhee's motion, Commissioner Woods' second, the CSBG responsible organizations were approved to be changed based on the APH recommendations on a 9-0-2 vote. Commissioner Dailey and Hinely abstained.
