**SUBJECT:** Authorize execution of a construction contract with CASH CONSTRUCTION CO., LTD., Pflugerville, TX for the Austin Clean Water Program: Upper Tannehill - Airport and IH 35 Wastewater Improvements Project in the amount of \$1,238,478.00 plus a \$123,847.80 contingency, for a total contract amount not to exceed \$1,362,325.80

**<u>AMOUNT & SOURCE OF FUNDING:</u>** Funding in the amount of \$1,362,325.80 is included in the Fiscal Year 2003-2004 Capital Budget of the Austin Water Utility.

This construction contract will provide for the installation of new wastewater pipelines in an area east of Airport Boulevard and north of 53<sup>rd</sup> Street. The improvements are intended to replace aging and deteriorated facilities and eliminate wastewater overflows that have occurred in this area. It is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows.

The project consists of the replacement and upsizing of approximately 4,806 linear feet of wastewater line between Middle Fiskville Rd. and Interstate 35 and includes the installation of the following: 618 linear feet of 12-inch wastewater line located between Middle Fiskville Rd. and Helen Street; 962 linear feet of 15-inch wastewater line located between Helen Street and Bennett Avenue; and 1,843 of 18-inch wastewater line located between Bennett Avenue and IH 35. The project also includes the installation of 1,383 linear feet of 8-inch wastewater line to collect flows from the service laterals and connect into the 18-inch wastewater line. Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-of-way, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 212 working days for substantial completion of this project.

Bid documents were distributed to 20 general contractors. Bids were opened on November 6, 2003. Eight (8) bids were received; Cash Construction Co. Ltd, submitted the lowest of the six (6) responsive bids:


