ELIGIBILITY REQUIREMENT: This written promotional examination shall be held in accordance with the Civil Service law and rules, and shall be open to any firefighter who at any time has continuously held for at least two (2) years a position in the Fire Lieutenant classification for which the examination is held.

ELECTRONIC REGISTRATION FOR WRITTEN EXAM: As required by Civil Service Commission Rule 7.06, all eligible candidates who intend to take the examination <u>MUST</u> register.

Candidates will now signup for examinations electronically at https://signup.com/go/CpkUQvj. Registration must be made no later than 9:00 AM, September 5, 2019. Once you register, a confirmation email, which will serve as your Letter of Intent, will be sent to you once the registration period has ended. Only those applicants who have registered by signing a Letter of Intent through the electronic process will be admitted into the examination.
