PROPOSAL

Demolish a ca. 1904 house now used as a duplex.

ARCHITECTURE

Two-story, rectangular-plan, side-gabled frame duplex apartment house with a full-width inset porch on plain columns and a screened sleeping porch above; single, double, and triple 1:1 fenestration; second-story addition to the left of the main block over the porte-cochere.

RESEARCH

The house was built ca. 1904; the first occupants were Alfred and Beulah Harvey, who lived here until around 1906. Alfred Harvey was a clerk at a boots and shoe store on Congress Avenue. George and Mina Roberdeau lived here from around 1906 to around 1910; he was a shipping clerk for John Bremond, the city's largest wholesale grocery business. Barbara Thrasher, a widow, moved into this house around 1914, after living briefly next door at 1204 West Avenue. She never had an occupation listed in the city directories, but her children were students while they lived here. She moved from this duplex to San Antonio around 1923.

The house appears to have been converted to a duplex by Ms. Thrasher around 1921; the renters were generally short-term, but middle class, including the proprietor of an automobile dealership, a construction estimator, and a clerk at a downtown department store. Another widow, Fannie Bogle, purchased the house around 1925; she was a real estate agent. Ms. Bogle lived here until around 1930. The house then had a series of renters again, including a traveling salesman, a teacher, a ladies' clothing store saleslady, a photographer, and an architect. Minnie Ludwig, a widow, rented an apartment in this house from the mid-1930s through the mid-1940s. She had no occupation listed.

Around 1946, the house was purchased by Samuel P. and Mary L. Ingram, who continued to rent out the other apartment in the duplex. Samuel Ingram was the city sanitarian; after he passed away, Mary Ingram, the manager and assistant supervisor of the Austin Athletic Club, and also an arts and crafts teacher for the City Recreation Department, lived here until around 1960. Tenants since that time have included people engaged in various office jobs.

STAFF COMMENTS

The house was listed with as a Priority 2 for research in the Comprehensive Cultural Resources Survey (1984).

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house does not reflect any architectural distinction in its design.
- b. **Historical association.** The duplex has a long history of owner occupation with tenants in the other unit; it has been the home and investment property of two widows. Probably the most prominent person associated with this house was Mary Ingram, the manager of the Austin Athletic Club, who lived here from around 1946 until around 1960. There do not appear to be historical

associations with this building significant enough to warrant individual designation as a historic landmark.

- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

Alfred Harvey is listed as living at 2006 Whittier, 2 blocks east of East Avenue, and south of E. 19th Street; he was a clerk for Frank DeLashmutt.

BIOGRAPHICAL NOTES:**Alfred and Beulah Harvey (ca. 1904 – ca. 1906)**

The 1910 U.S. Census shows Alfred W. and Beulah B Harvey living at 704 Henderson Street in Austin. Alfred W. Harvey was 32, had been born in Mexico, and was the manager of a shoe store. Beulah B. Harvey was 32, had been born in Texas, and had no occupation listed. They had 2 sons: L. Claire, 9; and Alfred K., 3. Both boys had been born in Texas. Also listed in the household was Beulah Harvey's sister, Dora Carter, a 29-year old Texas-born widow with no occupation listed.

His 1918 World War I draft registration card shows that Alfred Westrup Harvey was living at 714 Henderson Street in Austin. He was born in 1877, and was the store manager for Frank Delashmutt, at 608 Congress avenue. His wife was Bula B. Harvey. Alfred W. Harvey was of medium height and build and had blue eyes and light hair.

Alfred W. Harvey's 1934 death certificate shows that he was living at 1303½ Hillside in Austin at the time of his death. He was born in 1877 in Monterrey, Mexico, and was an insurance agent.

Mina Roberdeau was 30, had been born in Texas, and had no occupation listed. They had no children listed with them.

Mina Gem Roberdeau died in 1945. Her death certificate shows that she was born in 1877 in Texas, and was living at 310 E. 34th Street at the time of her death. She was a housewife.

Also at this address were William M. and Erna Studer, renters. William M. Studer was 27, had been born in Texas, and was a book-keeper in a store. Erna Studer was 27, had been born in Texas, and had no occupation listed. They had no children listed with them.

The 1930 U.S. Census shows Barbara Thrasher as the owner of an \$8,000 home in San Antonio. She was a 59-year old Texas-born widow with no occupation listed. With her lived her son, Robert E. Thrasher, 32, who had been born in Texas, and was a stenographer in a law firm.

Barbara Thrasher appears in the 1940 U.S. Census of San Antonio, where she owned her home worth \$4,000. She was a 69-year old Texas-born widow with no occupation listed. With her lived her son, Robert E. Thrasher, 42, who had been born in Texas, and was a book-keeper.

Her 1957 death certificate shows that Barbara Steussy Thrasher died in San Antonio, where she had been living for 35 years. She was a widowed housewife who had been born in Texas in 1871.

Fannie Bogle (ca. 1925 – ca. 1930)

Fannie Bogle appears in the 1930 U.S. Census as the owner of the house at 1913 Whitis Avenue, where she had 3 apartments in addition to her own living quarters. She lived here with her son, Bruce. Fannie Bogle was a 62-year old Texas-born widow who was the manager of an apartment house. Bruce Bogle, 30, was born in Texas, and was a chauffeur of a private car.

The 1920 U.S. Census shows Mrs. Fannie Bogle as a 54-year old widow who owned her home at 605 W. 16th Street in Austin. She is listed as a real estate agent. With her lived her 26-year old twin daughters, Ura, a draftsman, and Ina, a school teacher, and her son Bruce, 23, who had no occupation listed. Mrs. Bogle rented apartments in the same house to two families: a physician and a financier.

The 1910 U.S. Census shows Fannie Bogle as the wife of Douglas M. Bogle; they lived in an un-numbered house on Live Oak Street in South Austin. Douglas M. Bogle was 46, had been born in Tennessee, and was a real estate salesman. Fannie Bogle, 44, had been born in Texas and had no occupation listed. They had 4 children: son Mullen, 19, a real estate salesman; twin daughters Ura and Ina, 17; and son Bruce, 13. All the children had been born in Texas.

Fannie Bogle's 1937 death certificate shows that she was living on a rural route of Austin at the time of her death. She was born in Texas in 1865 and was the widow of D.M. Bogle. She was a housewife.

Business Woman Of Austin Dies

Rites for Mrs. Fannie Bogle Are Held

Mrs. Fannie Bogle, 72, Austin business woman, died late Saturday. She is survived by two daughters, Mrs. Ura Berry of New York city and Mrs. Ina Savage of Austin; two sons, M. E. Bogle of San Antonio and Bruce Bogle of Austin; three brothers, W. H. Speir, W. E. Speir, both of Elgin, and N. E. Speir of Austin.

Mrs. Bogle entered the real estate business in Austin in 1908 and was still active in this business at the time of her death.

Funeral services were held Sunday at 3 p. m. from the Hyltin Funeral home with the Rev. G. H. P. Showalter officiating. Interment was in Oakwood cemetery. Pallbearers were Van Smith, R. R. Massey, Frank Buckley, M. M. Speir, Weldon Speir, and Howard Speir.

The 1940 U.S. census shows Minnie Ludwig as the renter of this house. She was a 42-year old Texas-born widow with no occupation listed. With her lived her daughter, Ruby, 25, who had been born in Texas and worked as a retail sales manager for a ladies' ready-to-wear clothing store.

Minnie Ludwig appears in the 1930 U.S. Census as the wife of Ben Ludwig; they rented their home at 501 W. 19th Street in Austin. Ben Ludwig was 44, had been born in Pennsylvania to German-born parents, and had his own house-moving business. Minnie Ludwig was 37, had been born in Texas to German-born parents, and had no occupation listed. They had 2 children: Ruby, 17; and Ben, Jr., 10. Both children had been born in Texas. The family had a lodger, Jack Ford, 17, who had been born in Texas, and was a clerk for a State department.

Mrs. Minnie M. Ludwig died at the family home, 1206 West avenue, Friday. She is survived by one daughter, Miss Ruby Lodwig of Austin. The body will be at the Hlytin Funeral home until 2 p. m. Sunday when it will be taken to St. Paul's Lutheran church where funeral services will be held at 3 p. m. with the Rev. K. G. Manz officiating. Burial will be in Oakwood cemetery.

Samuel and Mary L. Ingram (ca. 1946 – ca. 1960)

His 1918 World War I draft registration card shows that Samuel P. Ingram, Jr. was living in Anniston, Alabama. He was born in 1899 and was a student at Wake Forest College in North Carolina. He was short and slender with auburn hair and brown eyes.

The 1920 U.S. Census shows Samuel P. Ingram, Jr. as the 20-year old son of Samuel P. and Lorena Ingram, who lived in Anniston, Alabama. Samuel P. Ingram, Jr. was born in Alabama and had no occupation listed. He had a younger sister, Julia, 11. His father, Samuel P. Ingram, Sr. 57, was an Alabama-born livestock dealer. His mother, Lorena Ingram, also 57, had been born in Alabama and had no occupation listed. Also in the household was Frances Sanlige (?), listed as a sister in law. She was a 68-year old widow with no occupation listed. The family also had two families of roomers – that of William S. Lloyd, a minister in the Church of Christ, and that of Thomas Cleveland, a dentist.

The 1940 U.S. Census shows Sam P. Ingram, Jr. and Mary Lee Ingram as the renters of a house at 106 E. 17th Street in Austin. Sam P. Ingram was 40, had been born in Alabama, and was a salesman for a real estate company. Mary Lee Ingram was 33, had been born in Texas, and had no occupation listed. They had a 3-year old son, Edsam Moore Ingram, who had been born in Texas. The family lived in Corpus Christi, Texas in 1935.

Samuel Ingram, Jr.'s 1950 death certificate shows that he was living in this house at the time of his death. He was born in 1899 in Alabama; his occupation was insect control. He died at the VA Hospital in McKinney, Texas.

Samuel P. Ingram, Jr., 51, 1206½ West Avenue, died in a McKinney hospital Monday morning. He is survived by his wife, Mrs. Mary Lee Ingram; one son, Edsam M. Ingram of Austin; his mother, Mrs. S. P. Ingram of Baton Rouge; two sisters, Mrs. J. G. Willox of Orlando, Florida, and Mrs. D. L. Judice of Baton Rouge.

Mary Lee Ingram

Mary Lee Ingram passed away on August 1, 1995, in Austin, Texas.

She was born on October 30, 1905, in Lampasas, Texas, where she spent her youth. She graduated from Mary Hardin Baylor University and taught school in Lampasas for a number of years.

In 1934, she married Samuel Peter Ingram Jr. In 1936, they moved to Austin, Texas, where they remained the rest of their lives. Her husband predeceased her in 1950.

Mary Lee Ingram worked for the City of Austin Parks and Recreation Department for 28 years before her retirement in 1973. Most of her work was as manager of the Autin Athletic Club. These close friendships with the students, their parents, and her co-workers continued after her retirement and were some of her greatest joys.

Mary Lee Ingram loved people. She had many close friends who she considered part of her family. She is survived by her son, Edsam M. Ingram; her daughter-in-law, Helen C. Ingram; and her extended family.



The house is shown on the 1935 Sanborn Fire Insurance Company map. There is no indication on the map that the house had a stucco finish at that time.



The 1961 Sanborn Fire Insurance Company map indicates that the house was stuccoed, but the configuration of the house appears to be the same as shown on the 1935 map above.

There is an indication in city records for a sewer permit for this address issued in 1919, but the permit is no longer extant.
