Tow Fee Study

### **Towing Services**

Towing is vital to maintaining the infrastructure of a city. Without towing services, Austin would have a hard time functioning. Private property impounds performed and contracted by businesses/individuals alleviate use of city resources by:

- Clearing vehicles parked illegally in fire zones and handicap parking spaces
- Removing abandoned or junked vehicles
- Clearing right of way to access private properties
- Securing parking lot from unauthorized use of resident/tenant/merchant spaces

#### Request for Increase

Austin towing companies are requesting an increase for non-consent private property tows (PPIs), performed in the City of Austin from the current rate of \$150 to \$185.

- Current Austin Rate \$150
- Current Local Metropolitan Average \$ 212.73
- Current Major Texas City Average \$199

#### Consent vs Non-Consent Tows

Consent Tows: a tow of a motor vehicle initiated by the owner or operator of the vehicle or by a person who has possession, custody, or control of the vehicle. The tow does not include a tow of a motor vehicle initiated by a peace officer investigating a traffic accident or traffic incident that involves the vehicle.

Non-Consent Tows: a tow that is not a consent tow.

The tow fee study is for non consent – private property tows, herein known as PPIs.

## Light Duty Vehicle Tows

- \* Light duty vehicle tows are the most common type of tow requested.
- \* Light Duty Vehicle is your standard vehicle with a total GVW (Gross Vehicle Weight) of 10,000 lbs.
- \* This tow fee increase request will only encompass light duty vehicle tows.
- Examples: sedans, pickup trucks, SUVs, and vans

#### Current Light Duty Impound Fees

- \* Example of a vehicle impounded for 1 day. The following is a breakdown of the total cost:
- \* \$150.00 tow fee
- \* \$20.00 impound fee
- \* \$20.00 storage fee
- \$3.30 sales tax (taxed items are storage and impound fee)
- \* Total fee: \$ 193.30

#### 13-6-141 TOWING FEE STUDY:

A "towing fee" study is used to determine fair market value of non-consent tows originating in the City of Austin, including the consideration of financial information provided to the city by the towing company that requested the study.

#### Consumer Price Index

The Consumer Price Index (CPI) is a measure of the average change over time in the prices paid by urban consumers for a market basket of consumer goods and services.

#### Consumer Price Index + Tow Rate

Consumer price index from January 2006 to December 2018 has increased 23.64% at an average rate of 1.85% per year as calculated by APD's Finance Office.

Using the CPI increase since 2006, the \$150 rate for non-consent tows would now equal \$185.46.

# Living Wage Rate

- \* In 2008, the City of Austin shows the Living Wage rate to be at a rate of \$10.90/hour
- \* In 2016, the City of Austin shows the Living Wage rate to be at a rate of \$15.00/hour
- \* This is an increase of 38% between 2008 and 2016. Using the Living Wage increase since 2008, the \$150 rate for non-consent tows would now equal \$207

# Neighboring Agencies

#### **Travis County**

As of current date, Travis County private property tow fee is the state regulated rate of \$255.00.

#### **Williamson County**

As of current date, Williamson County private property tow fee is the state regulated rate of \$255.00.

## City Comparisons

APD Wrecker Enforcement surveyed agencies from the 10 largest cities in Texas, as well as the surrounding Austin Metropolitan Area.

Austin is the 4<sup>th</sup> largest city in the survey.

### Austin Metropolitan Area

Of the 10 surrounding counties surveyed, it was discovered that all maintain the state regulated tow fee rate of \$255.00

The average non-consent tow rate for the Austin Metropolitan area is \$212.73.

## Large Texas Cities

Of the ten large cities surveyed, five of the cities maintain the state regulated tow rate of \$255.

Of the ten large cities surveyed, the city of El Paso maintains the lowest tow rate of \$100.

The average non-consent tow rate for Texas large cities is \$199.00

#### Tow Fee Increase Considerations

- \* On June 6, 2019, the City of Austin Wrecker Ordinance was amended to adjust the non-consent tow fee, excluding the non-consent private property tows.
- \* Private property tows represent over 58 % of all non-consent tows (obtained during the 12 month period of 5/1/2019-4/30/2019).
- \* Consent tows are not part of this established fee schedule.

#### Final Recommendation

\* After extensive review and consideration of the tow fee study results and significant change in the Consumer Price Index, the Austin Police Department identified that an increase for non-consent, private property tows to \$185 is a reasonable request. By comparing the Austin rate to neighboring communities and other large cities in Texas, the current rate of \$150 is non-competitive, below average, and deserving of modification to meet up to date standards.
