## **Background**

The Austin/Travis County Health and Human Services Department (HHSD), through an interlocal agreement with Travis County, has contracted with Capital IDEA to provide Workforce Development services to unemployed and under-employed low-income residents of the City of Austin and unincorporated Travis County since April 1, 1999. The current contract is a three-way contract for the period October 1, 2002 to September 30, 2003.

This extension will align the Capital IDEA contract period with the rest of the social services contracts—January 1, 2004 to December 31, 2004. This action also converts the contract from a three-way to separate City and Travis County contracts.

The Fiscal Year 2003 contract is presently operating under the holdover provision pending Council approval of an extension to December 31, 2003. Council approved Capital IDEA's calendar year 2004 contract on December 11, 2003.
