**SUBJECT:** Authorize execution of a construction contract with CASH CONSTRUCTION COMPANY, LTD, Pflugerville, TX for the Austin Clean Water Program - Little Walnut/Buttermilk @ Centre Creek Project in the amount of \$3,009,857 plus a \$300,985.70 contingency, for a total contract amount not to exceed \$3,310,842.70.

AMOUNT & SOURCE OF FUNDING: Funding in the amount of \$3,310,842.70 is included in the Fiscal Year 2003-2004 Approved Capital Budget of the Austin Water Utility.

MBE / WBE: 18.39% MBE and 3.20% WBE subcontractor participation.

This construction contract will provide for wastewater improvements within the flowline of Little Walnut Creek; bounded on the south by U.S. Highway 183 and to the northwest by Cameron Road. The improvements are intended to replace aging and deteriorated wastewater facilities and eliminate the wastewater overflows that have occurred in this area. This project is part of the Austin Water Utility's Austin Clean Water Program (ACWP), which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows.

The proposed improvements include the installation of approximately 4,100 linear feet of 42-inch sanitary sewer within the creek bed, streambank stabilization, and restoration of areas of the creek bed after construction. Due to the potential for unknown subsurface conditions and unforeseen issues arising from construction within the creek, a 10% contingency in funding has been included to allow for the expeditious processing of any future change orders. The contract allows 350 working days for completion of this project.

Bid documents were distributed to 15 general contractors. Bids were opened on November 21, 2003. Cash Construction Company, Ltd. submitted the lowest of 7 bids received:

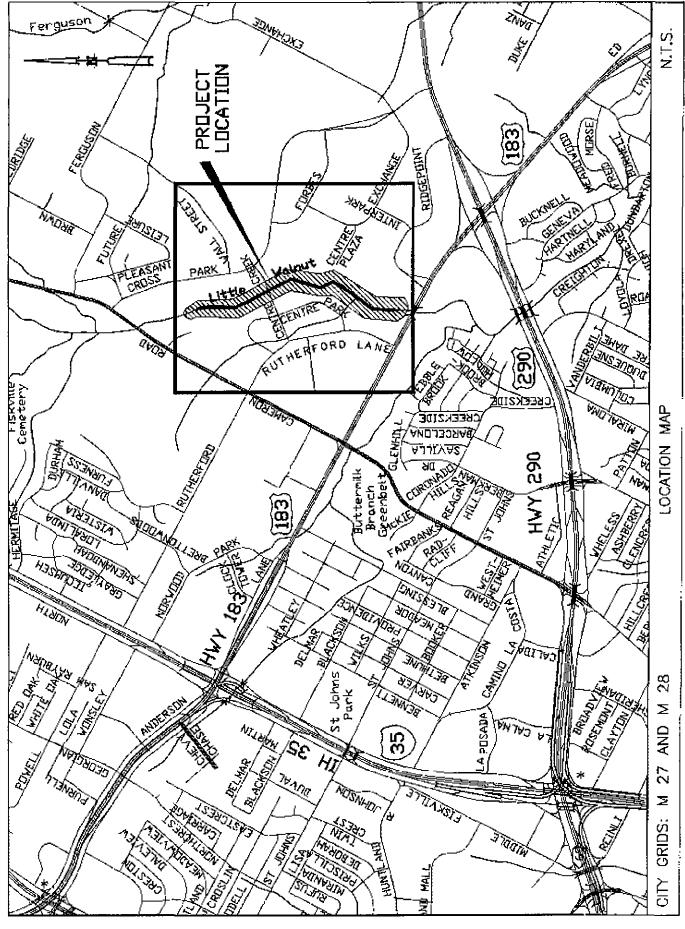
