

# **Annual Internal Review**

## **Codes and Ordinances Joint Committee** (Official Name of Board or Commission)

The Board/Commission mission statement (per the City Code) is:

§ 2-1-207 - CODES AND ORDINANCES JOINT COMMITTEE.
