

Impact of the City of Austin's Ordinance No. 20190910-002 on Electric Ratepayer Classes



On September 10, 2019, the City Council of the City of Austin adopted Ordinance No. 20190910-002 establishing a revenue requirement for electric rates for utility bills rendered on or after November 1, 2019. This written report describes the effects of the City Council's action upon each electric customer class. The City posted this report with the City Clerk of the City of Austin on September 16, 2019, pursuant to the Public Utility Regulatory Act §33.103.
