Please tell us about yourself and why you would like to serve on the District Board.	As someone who has learned about Lions Municipal Golf Course over the past 47 years, and has been involved in the efforts to maintain the city's lease on the course during those years, I would be glad to serve with others in successfully achieving the primary goal of preserving the 141.35 acres golf course for the public - FOREVER.
Please describe any property or business you own or rent in the District and how long you have been associated with it	We own our home at 3404 Southill Circle, and moved to this address in mid-1970. During the first three years of our married life, we rented a home at 1621 Waterston (1959-1962). Thus we have lived in the district for 52 years.

**Please describe any background, interest or experience with golf, historic preservation, or open space.**

I did take golf for a semester at UT as one of my required PE courses. My father, husband and son have played golf. My son learned to play at MUNY while a student at OHenry Middle School - and is still a regular golfer, though living in Amarillo. I have certainly had an interest in open space and historic preservation throughout my adult life. I served on a Austin citizen committee to develop a Historic Revolving Fund. My service on the Austin Parks Board and the Environmental Board added to my knowledge of and appreciation for the importance and value of open space. I traveled to Del Rio for a number of years for my husband to participate in a Labor Day golf tournament -- enjoying, especially, the cold spring water available on the course from a natural, underground spring - as well as the pleasure of watching the golf matches on the greens and fairways watered with the spring water.

**Please describe any affiliation with the University of Texas.**

My father got his degree at Univ. of Texas in Civil Engineering in 1922. I came as a Plan II freshman to UT in 1952, graduating in 1956. I returned to UT for graduate school in summer 1958 and was invited to teach Freshman English part-time. I taught for 2 semesters, while taking courses in English and Government - deciding that I would concentrate on Government rather than English. My adviser, Dr. William Livingston, suggested that I work part-time as a researcher for the Institute of Public Affairs (1960-61). I worked full-time as an Assistant Dean of Women at UT 1961-62, and received my Masters Degree in 1962. My father gave me a Lifetime Membership in the UT Ex-Students Association at that time. For a few years in the 1970's I volunteered as an Art Docent for the University of Texas Art Museums. I served on the Liberal Arts Advisory Council 1990 - 2005, and am a member of the Chancellor's Council.

**Please describe any affiliation with the City of Austin.**

My first appointed position on a City board or committee came in 1973, when the Austin City Council named me Chair of an Ad Hoc Committee to Save Muny. After the agreement between UT and the City of Austin to let the golf course lease extend to 1987, I was asked to serve on the Goals Assembly tasked with developing a framework for a new City of Austin Master Plan. I served on the Environmental committee. I was appointed to the Parks Board, Planning Commission, Water/Wastewater Commission and Environmental Board over the next 20 years. Because of my interest in Saving Muny, I became an "at-large" member of the Golf Advisory - made up of representatives of various Golf Associations that use City of Austin golf courses - and am still serving in that capacity. The Golf Advisory meets with the head of the City's Golf Department under the Parks and Recreation Dept. In 1989, as the City of Austin and UT were negotiating for a new lease for Lions Municipal Golf Course, I was asked to serve as one of five citizens plus one City Council member to help finalize details for the Brackenridge Development Agreement, allowing for the city to continue leasing the golf course for at least another 30 years.

**Please describe any current involvement in community organizations.**

I am serving on the board of the West Austin Neighborhood Association, and was on the board during the time WANG worked with the City of Austin Planning staff developing a Neighborhood Plan, along with several adjacent neighborhood areas. The Central West Austin Combined Neighborhood Plan was approved by City Council in 2010. A "SAVE MUNY" group was again organized in March 2008, after the Brackenridge Tract Task Force recommended that the Lions Muny lease be allowed to expire in 2019. It has been a pleasure to work with other dedicated neighbors, golfers, and Lions Club members, sharing ideas and tasks and recovering evidence of Muny's rich history - and seeking to spread the word about its worth. I joined the Austin Colony chapter of the DAR in 2005, and served as Conservation Chair for several years. My primary focus, since learning of the appointment of the Brackenridge Tract Task Force, has been Lions Municipal Golf Course - its history, preservation, and value to this community.

Besides the various City of Austin boards and commissions, I have served on the Hill Country Conservancy Board, Save our Springs Alliance board, Member of the Texas Mental Health Association Board (1970's), and the board of We CARE Austin.

**Please note your current occupation and any special skills that you would bring to this position.**

My current "occupation" is researching the history of Lions Municipal Golf Course, and trying to interest others in the importance of maintaining Lions Municipal Golf Course as an "historic" 18-hole public golf course at its current location here in Austin, TX. I have many years of accumulated news articles, documents, etc. about the course and the people associated with it, what others have written about it, etc. I have followed legislation related to Muny at the Legislature the last two sessions, and am familiar with researching legislative matters.

**Do you, your employer, or any associated organization, have an interest in the ownership or operations of the Lions Municipal Golf Course ("Muny")? If yes, please describe.**

Save Muny of course has an "interest" in the ownership and operation of Lions Municipal Golf Course -- Save Muny wants to be sure that the course remains FOREVER as a public, affordable, historic space. And if that means that ownership of the course should change, because the goals of the present owner do not necessarily assure that the course remain, then my interest is in changing the ownership. I would personally benefit from a change of ownership for the course that would provide for Muny FOREVER GREEN in that any years I might have remaining, I would be able to spend doing things more related to my family.

I feel that by my service I can continue my efforts to better our community by assuring that my children, grandchildren, and the people of Austin can continue to have the wonderful experiences I had at Muny and the related land.

I have lived in West Austin all of my life, with brief exceptions. I grew up in a house at 3707 Windsor Road, and before living on Pemberton Place we owned a house at 2415 Vista Lane.

In the past, when I chaired the board of Laguna Gloria Art Museum, we commissioned a study of the site to understand the historic and recreational importance of the property. I have been involved in several efforts to preserve the historic home on the site as well as ensure public access to its considerable open space and lakeside.

<b>Please describe any affiliation with the City of Austin.</b>	I served on the Austin Tomorrow Ongoing Plan Committee in the 1980's. The Committee was charged with overseeing compliance of City projects with the City's master plan. I have no current affiliation with the City of Austin.

**Please tell us about yourself and why you would like to serve on the District Board.**

I have been fortunate to live in West Austin for the vast majority of my life. My first vivid memory of Muny is being there with my grandfather, around the age of five. He had asked me if I wanted to go "hunt for arrowheads" at Muny and, of course, I badly did. We walked several blocks to the course and he guided me into one of the thickets of trees. He then told me to start looking. What I didn't know at that time was that he had several arrowheads in his pocket and was making sure that I would not be going home emptyhanded. It probably was not until I participated in a UT archeology field study course that I fully appreciated that "hunting" for arrowheads requires tedious excavation and that you shouldn't expect to find them lying on top of the ground at Muny. My grandfather first played Muny in the 1930s and enjoyed playing it almost daily after retiring from the Austin Fire Department in 1969. Since 1950 it has been a course for everyone, regardless of background. My passion to preserve it is deeply rooted in my love and admiration for my grandfather and his love of Muny. That passion led to me participating in the course's historical research and - after fully grasping the significance of its place in golf and civil rights history - advocating even more strongly that Muny needs to be saved; not only as an iconic local municipal golf course but as a priceless educational asset for the residents and visitors of Austin.

I have lived at 2204 Bridle Path for 29 years. My great-grandfather purchased the raw land in 1925 and my grandparents built the first home on the property in 1934.
