#### **CALL TO ORDER**

# 3a. Discussion and Action – Approval of July 10, 2019 Meeting Minutes

Chair Acuna entertained a motion for approval. Commissioner White moved for approval. Seconded by Commissioner Gattuso. Passed on a 6-0-1 vote. Abstention made by Commissioner Barden.

Chair Acuna entertains a motion to defer this item. Commissioner Steyaert motioned for deferment. Seconded by Commissioner Barona. Passed unanimously 6-0. Commissioner White joins the dais.

## 4. NEW BUSINESS

# 4a. Discussion and Action – Multi-Family Recycling Capacity Administrative Rule Amendments RCA

Commissioner Gattuso said she had no edits and it was exactly what was recommended. Chair Acuna entertained a motion for approval. Commissioner Gattuso moves for approval. Commissioner Barona seconds. Passed unanimously, 7-0.

## 4b. Discussion and Action - Organics Processing RCA

Chair Acuna entertained a motion for approval. Commissioner Barona moves for approval. Seconded by Commissioner White. Passed unanimously, 7-0.

## 4c. Discussion and Action – FY20 Proposed Budget Recommendation Vote

Commissioner White had a question regarding the review of the clean community fee. Brent Paige, ARR, said that a cost of service analysis is done every year, but a major review is done every 3 to 5 years. Commissioner White asked if there were increased services, what would it take in order to increase the clean community fee back up to be able to accommodate additional services? Mr. Paige said that after ARR proposes the rates, City Council or the City Manager office could add more services to ARR's proposed rates. If something came up in the mid-year budget cycle that Council felt that it fell within ARR's purview, then a budget amendment would occur; or the fee schedule could be amended to accommodate for new rates as well.

Chair Acuna entertained a motion for approval. Commissioner Steyaert moves for approval. Seconded by Commissioner Gattuso. Passed unanimously, 7-0.

#### 5. STAFF BRIEFINGS

## 5a. Director's Report: Solicitations Update, Statistical Reports and Performance Measures

Richard McHale, ARR, said that on the September 19<sup>th</sup> council agenda the Parks and Rec Department (PARD) has a contract for purchase and installation of recycling containers in parks. Chair Acuna asked if this was from PARD's budget. Mr. McHale confirmed that it's from PARD's budget. Commissioner Gattuso asked about the containers in the downtown area and the associated costs. Mr. McHale said there are some discussions being held about alternate designs that would cost less than the current designs.

Chair Acuna asked the representatives from Organics by Gosh if the delivery spot is still going to be at the same location. Mr. McHale said he wasn't sure if the details could be discussed. Adam Gregory, TDS, said that [the Anti-Lobbying Ordinance] doesn't prohibit any conversation in a public meeting. Mr. McHale said to direct any questions to the City Purchasing Department. Mr. Gregory said that the Commission] can't review, evaluate, and recommend contracts if they can't ask questions about a contract that is sensitive. Chair Acuna said that Mr. Gregory's comments are well taken.
