<u>SUBJECT:</u> Authorize negotiation and execution of a contract with ACTION TARGET, INC., Provo, UT, for the purchase and installation of automated target systems for the Austin Police Department Firing Range for firearms training and qualification for cadets and the annual re-qualification of police officers in an amount not to exceed \$52.092.

AMOUNT & SOURCE OF FUNDING: Funding is included in the Fiscal Year 2003-2004 Approved Operating Budget of the Police Department.

PURCHASING: Best proposal of three proposals received.

MBE / WBE: This contract will be awarded in compliance with Chapter 2-9 of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified, therefore, no goals were established for this solicitation.

This contract is for the purchase and installation of an automated turning-target system and a "running man" target system at the Austin Police Department Firing Range. These systems are replacements for the current target systems, which are 13 years old and require frequent repair. Replacement parts for the current target systems are no longer in production.

The turning-target and running man systems are necessary to provide firearms training and qualification for cadets and for the annual re-qualification of police officers. Action Target will provide turnkey installation of the Power-90 Turning Target system and Running Man system. This includes 30 stationary turning stations, the running man system and Smart Range 2000 software, which operates both systems. The purchase price includes installation, training of the firing range staff in system operation and a three-year maintenance agreement.

An evaluation panel made up of APD Training Academy command personnel, firing range personnel and APD finance personnel ranked the proposals based upon mechanical design, software design, ease of use, factory support, prior experience, personnel qualifications, references, installation schedule and cost. The recommended awardee has been manufacturing target systems since 1986 and has a wide range of experience in the installation of target systems for federal, state and municipal customers.
