- Commission Ben Heimsath reported the Historic Commission has learned that there has been a change in State law that requires a super majority on the Landmark Commission, Planning Commission and the Council to zone a property as historic over a property owners objections.
- Commissioner Cynthia Weatherby reported that the Urban Transportation Commission (UTC) received a report on the electric assist pedicabs and that the UTC supports the plan.
- Commissioner Felipe Garza reported that the Arts Commission approved the TEMPO 2D project which includes ten murals to assist with graffiti abatement and the commission also discussed how the Hotel Motel Bed Tax (HOT funding) is allocated.
- Commissioner Richard DePalma reported that the Parks and Recreation Board reported that the Parks Department promoted Kimberly McNeely as Direction of the Parks and Recreation Department and that Board created a working group relating to parks finance that will research funding mechanisms to help support the park system. Trail Foundation is working in partnership with the Parks Department and Urban Land Institute to determine the feasibility of overseeing the maintenance, operation and programming of the ten mile trail around Lady Bird Lake.
